KEY RISKS:

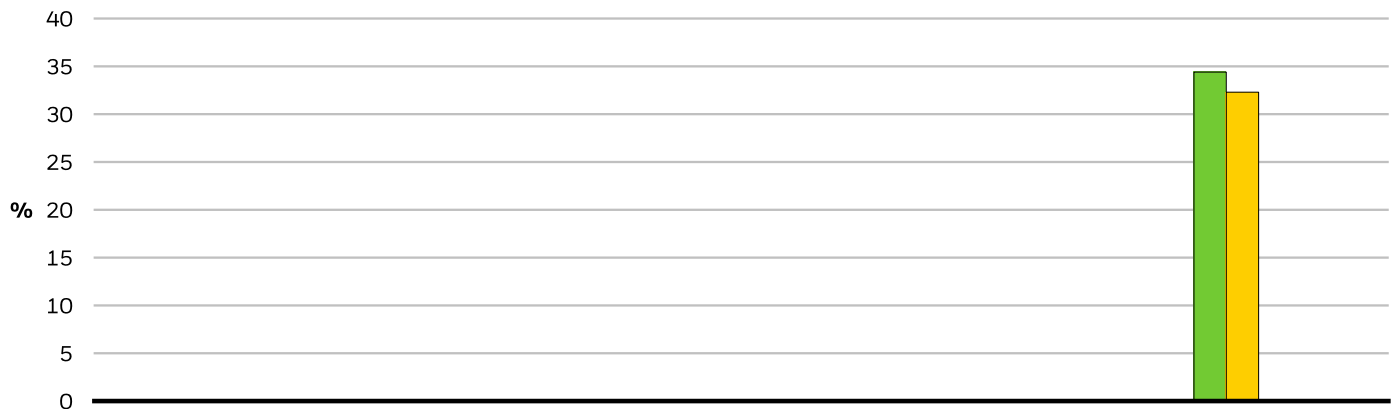

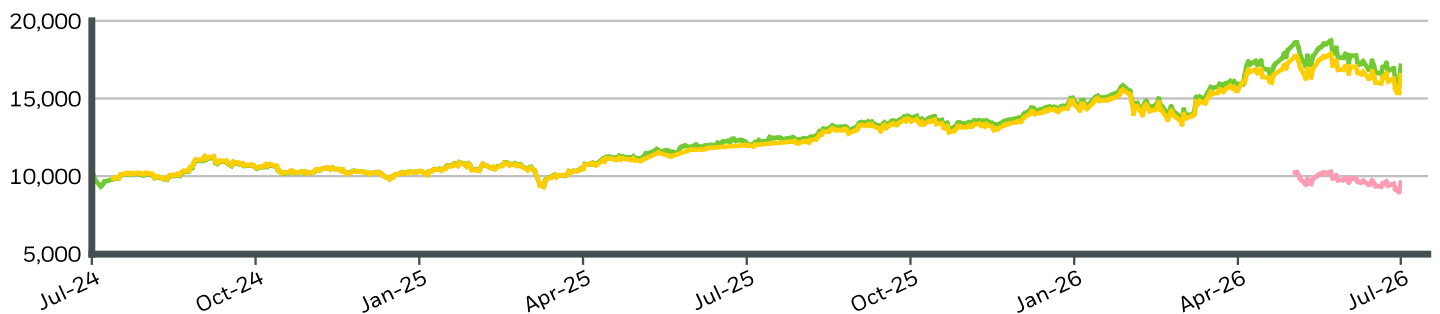

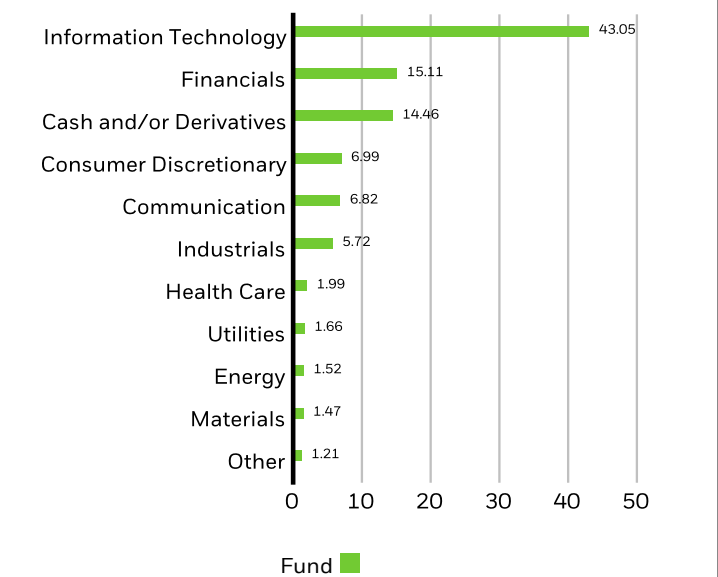

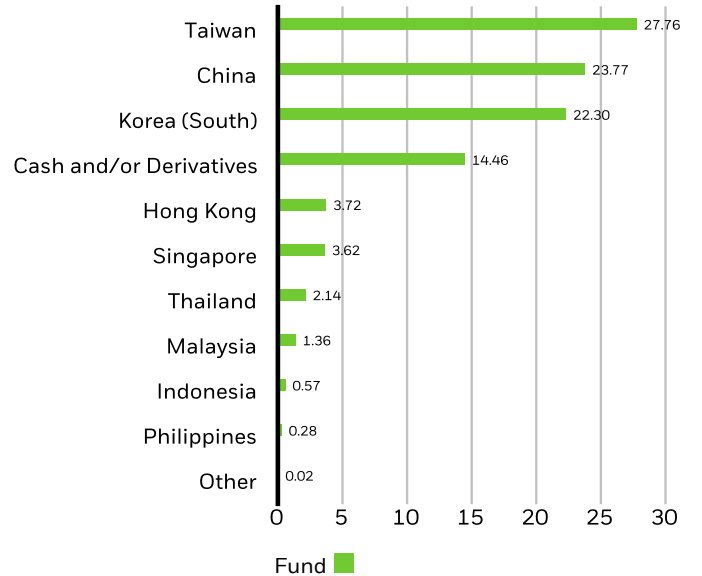
