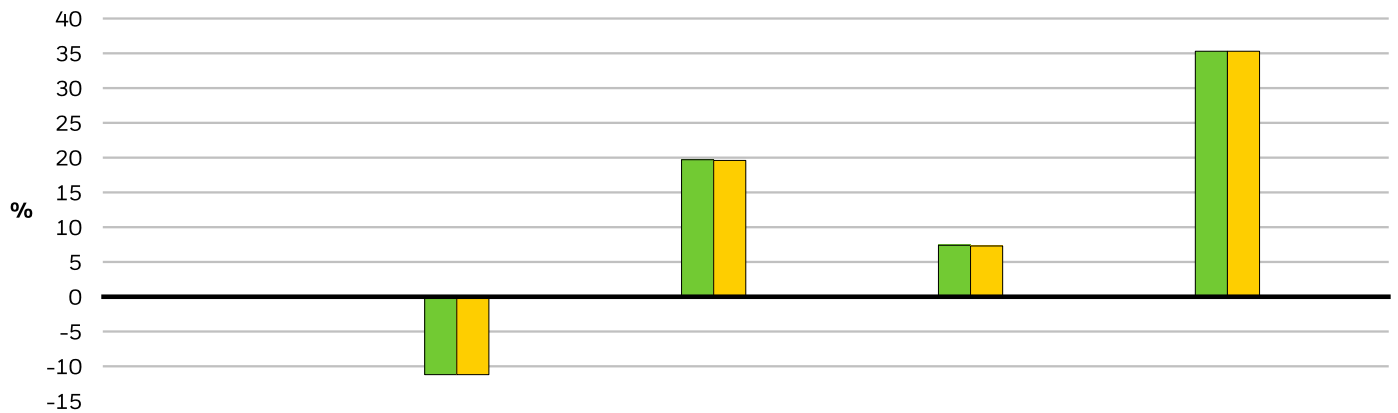

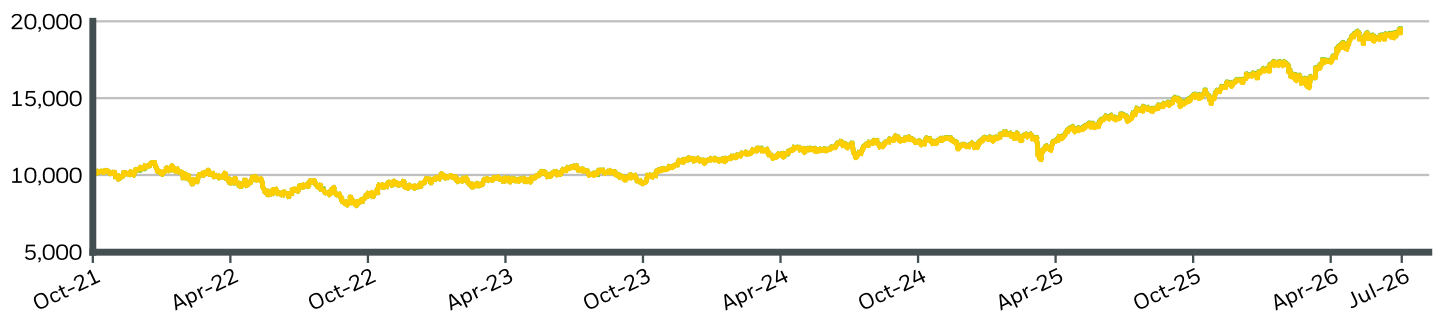

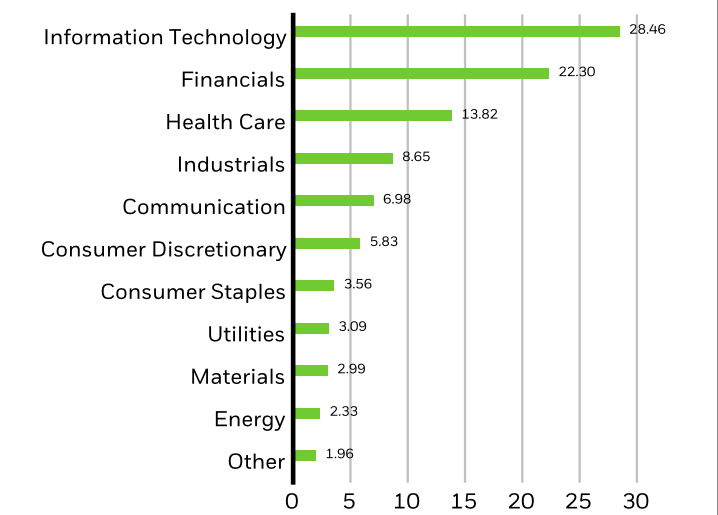

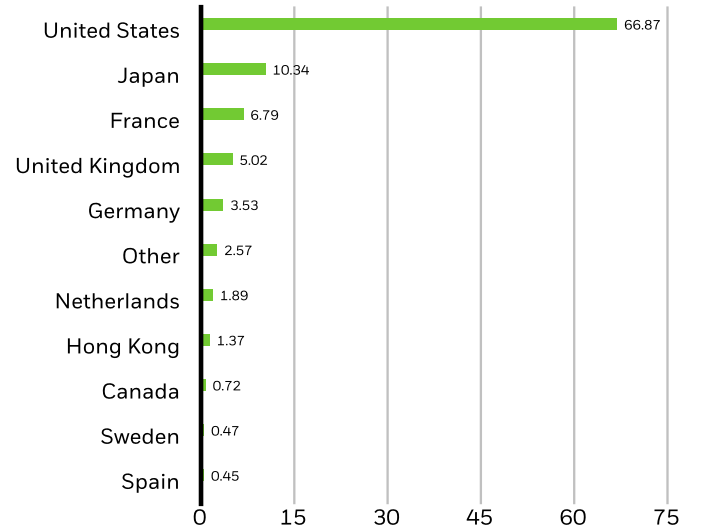
SECTOR BREAKDOWN (%)
