FUND OVERVIEW

The iShares Smart City Infrastructure UCITS ETF seeks to track the investment results of an index composed of developed and emerging market companies that provide services and solutions for development and efficient running of Smart City infrastructure in a sustainable manner.

The Index reflects the performance of certain global equity securities which derive significant revenues from sectors associated with two global thematic trends: (i) smart cities; and (ii) infrastructure. These include, among others, cellular site equipment, metal recycling providers, multi-type passenger transportation, water treatment agents manufacturing, general waste collection, and residential property owners.

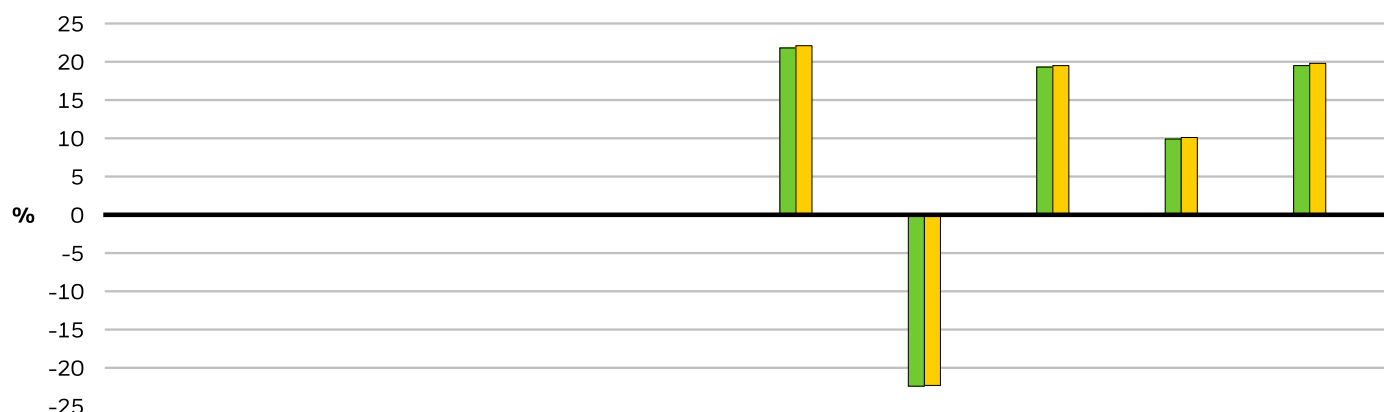

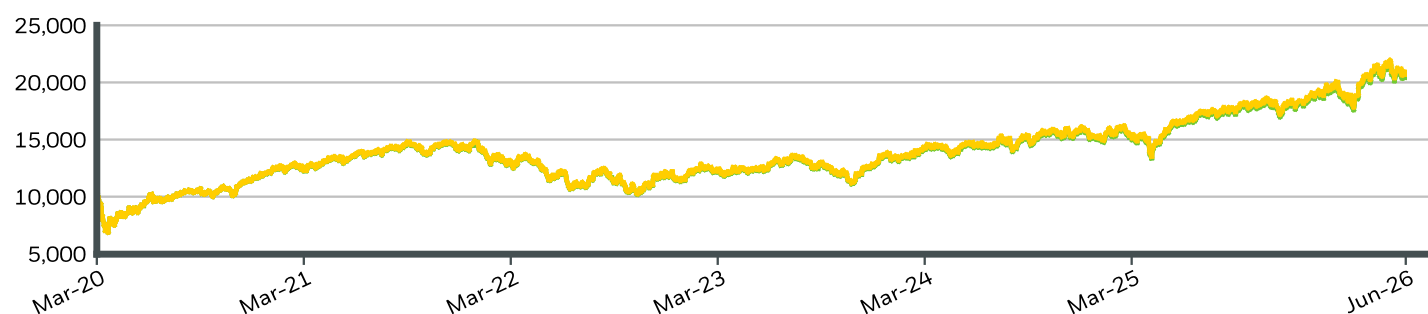

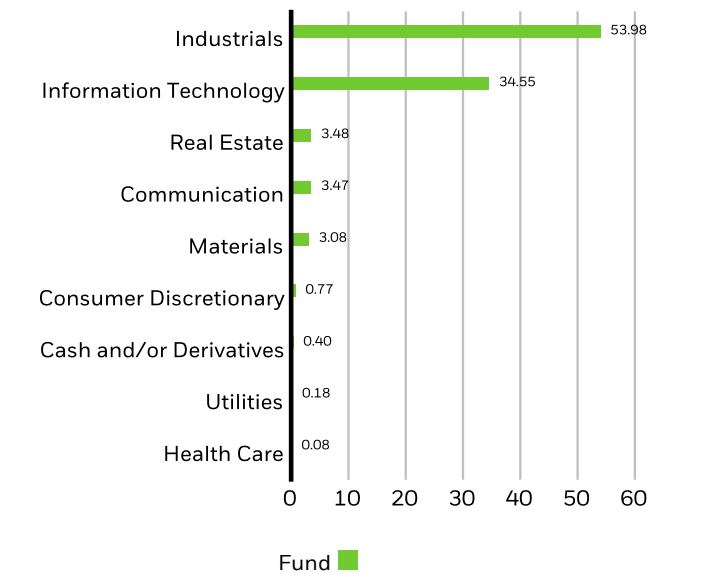

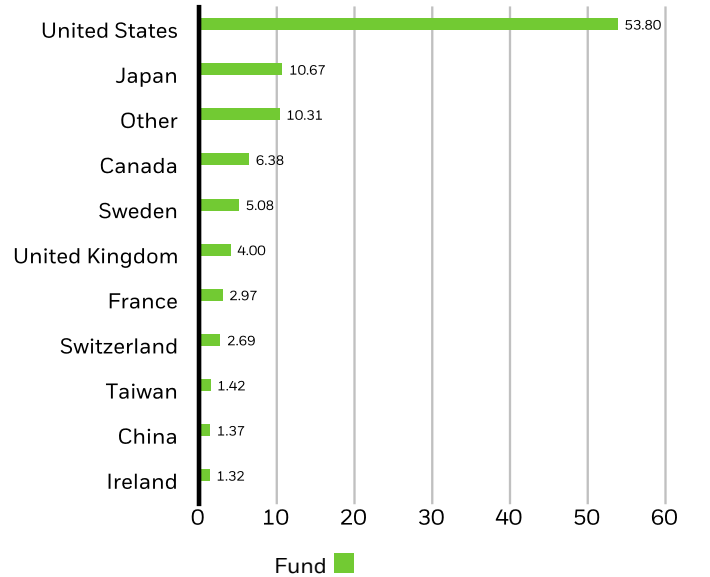
