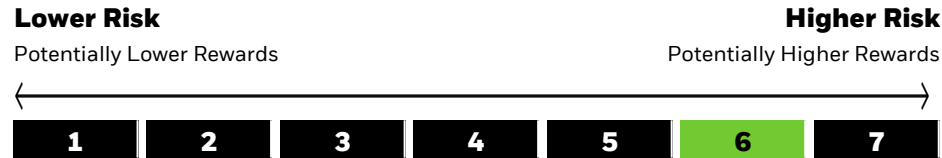
FUND OVERVIEW

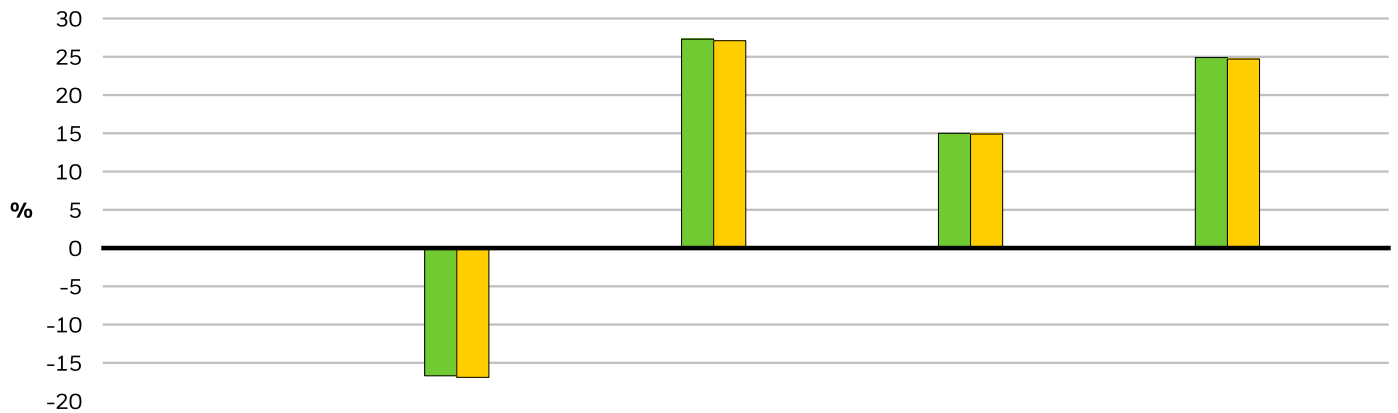

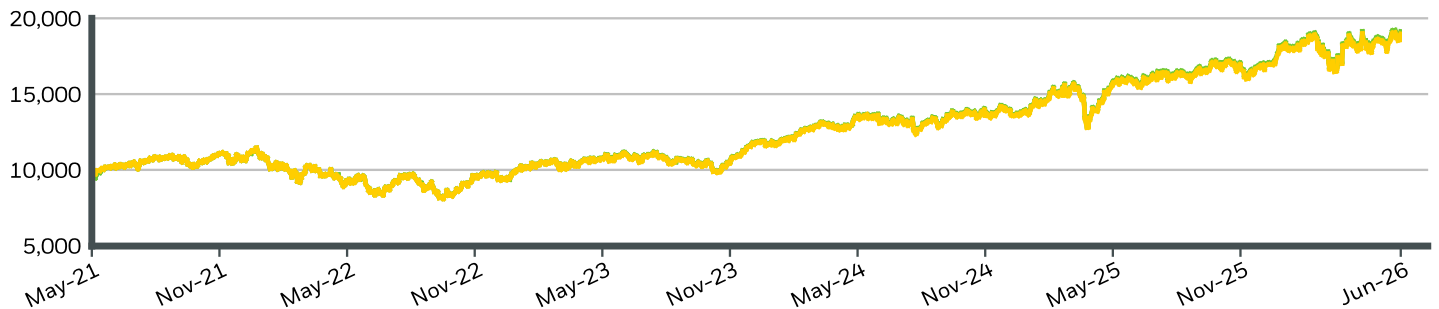

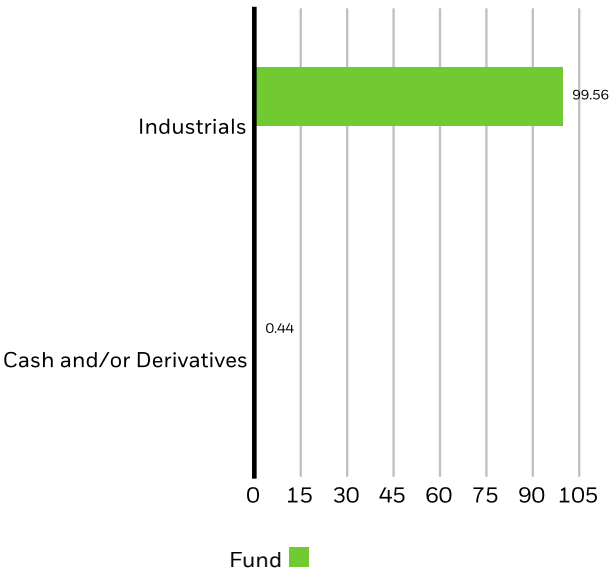

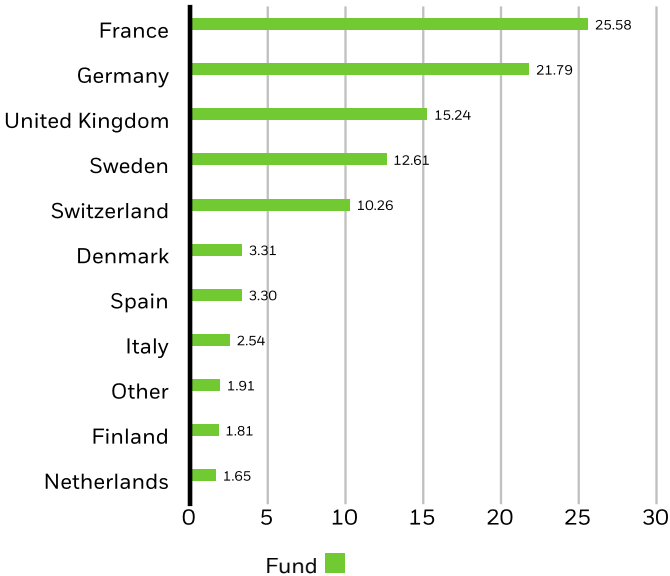
