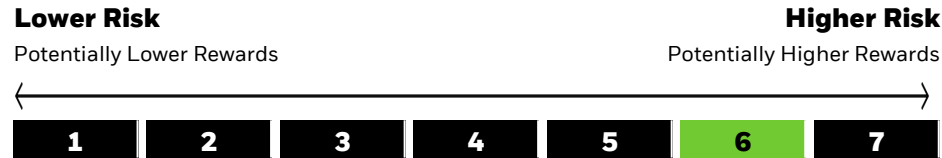
FUND OVERVIEW

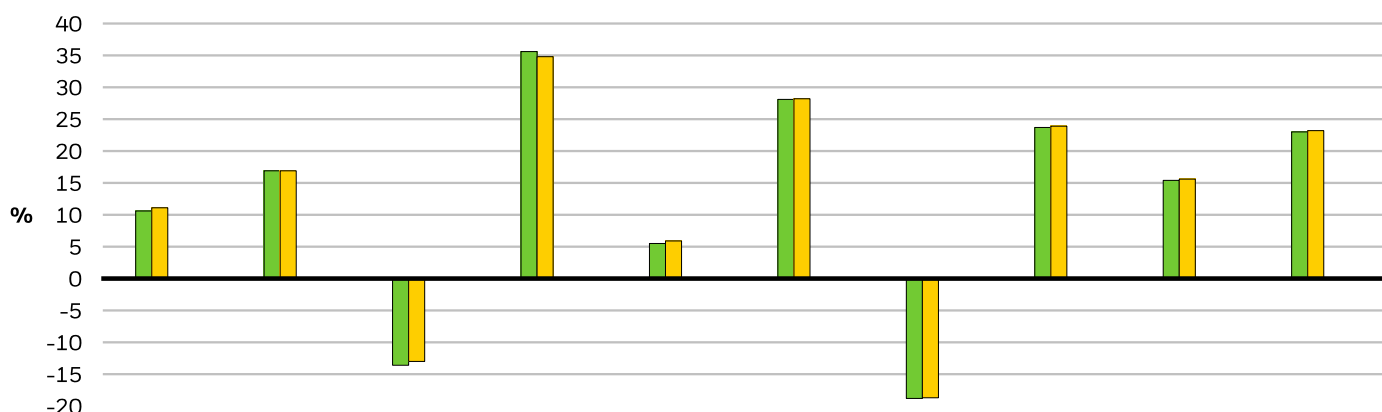

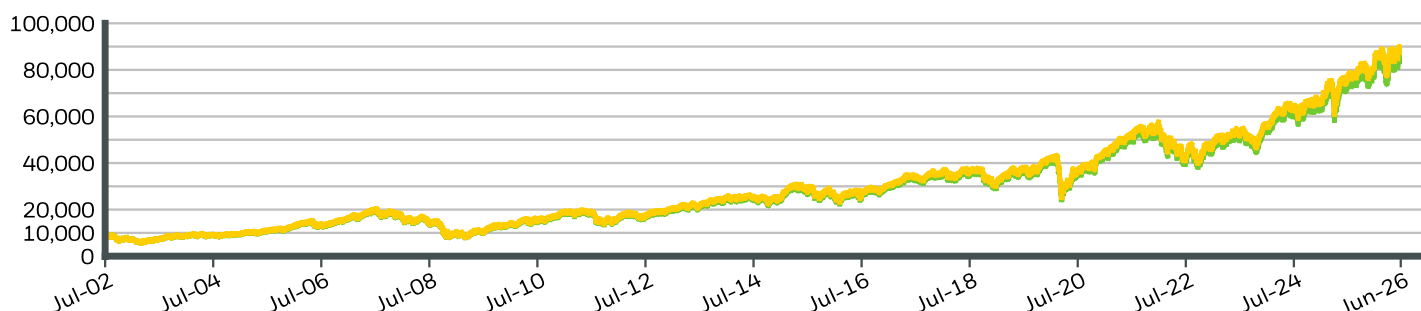

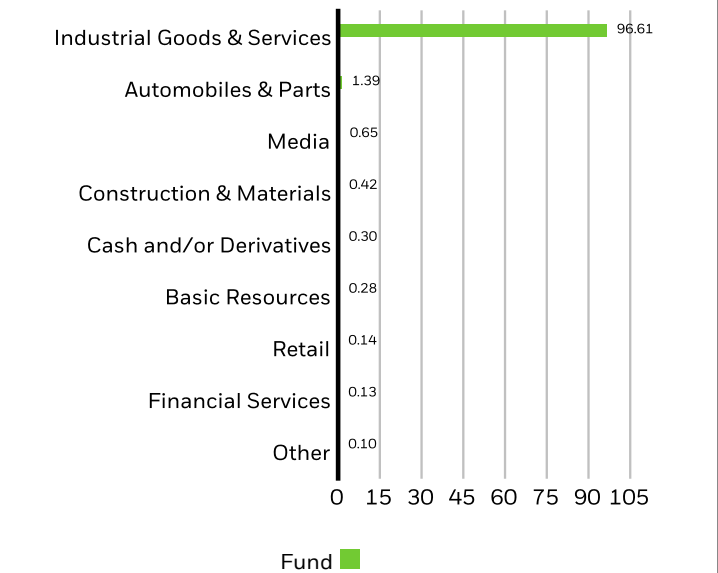

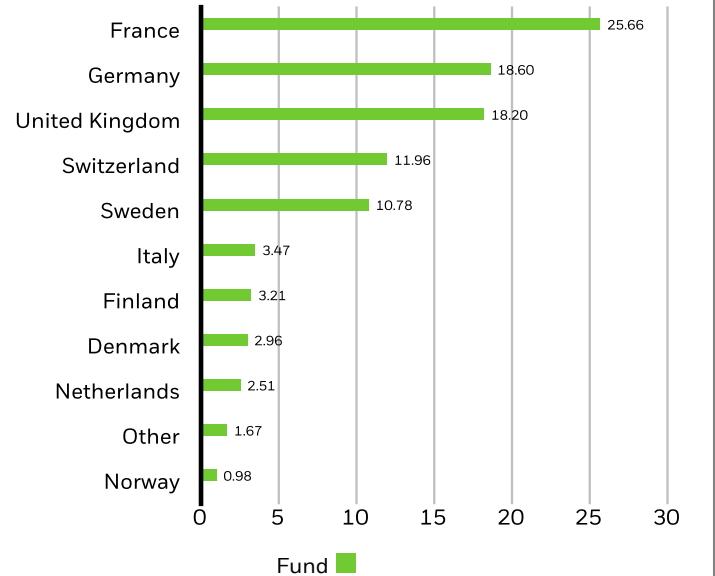
