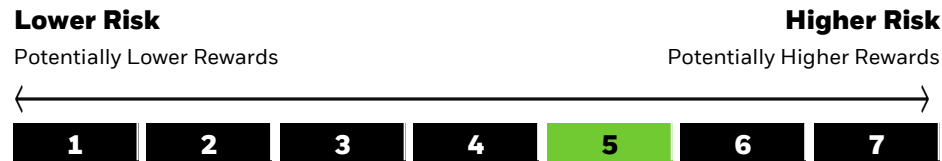
FUND OVERVIEW

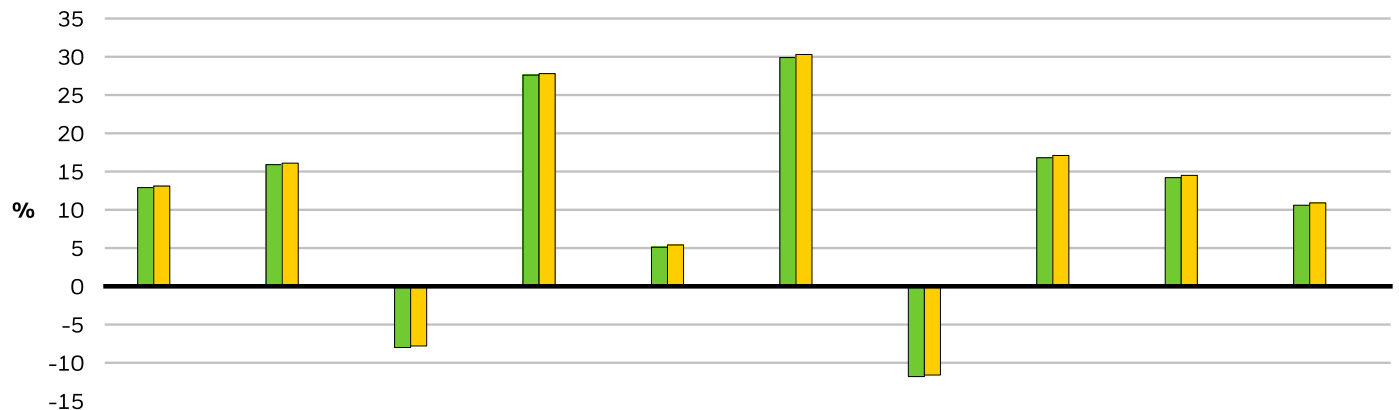

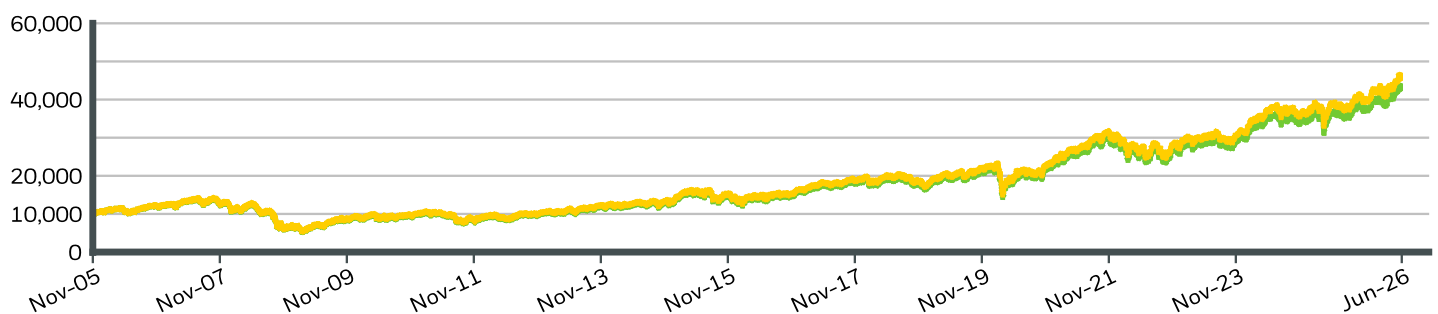

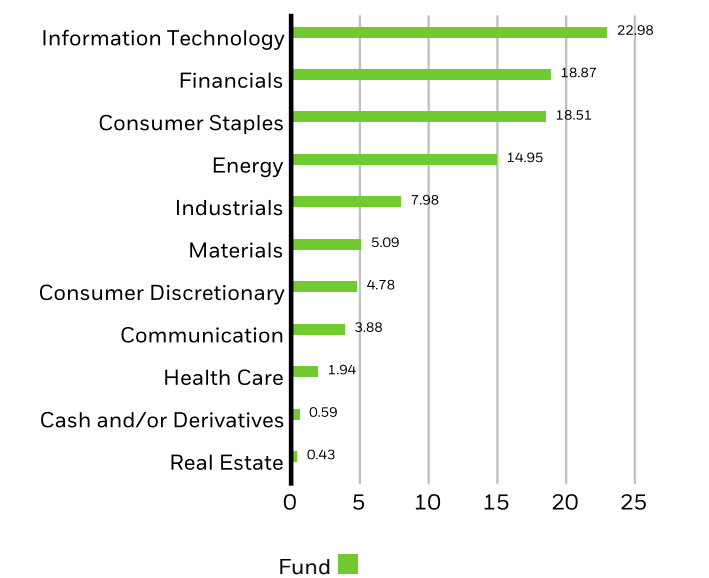
