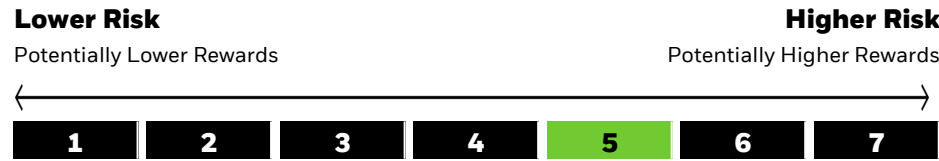
FUND OVERVIEW

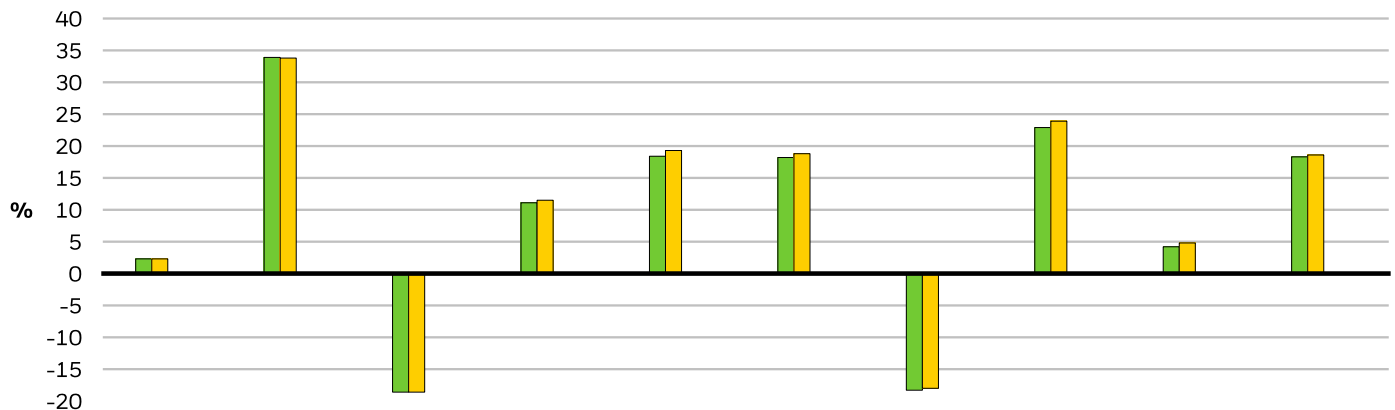

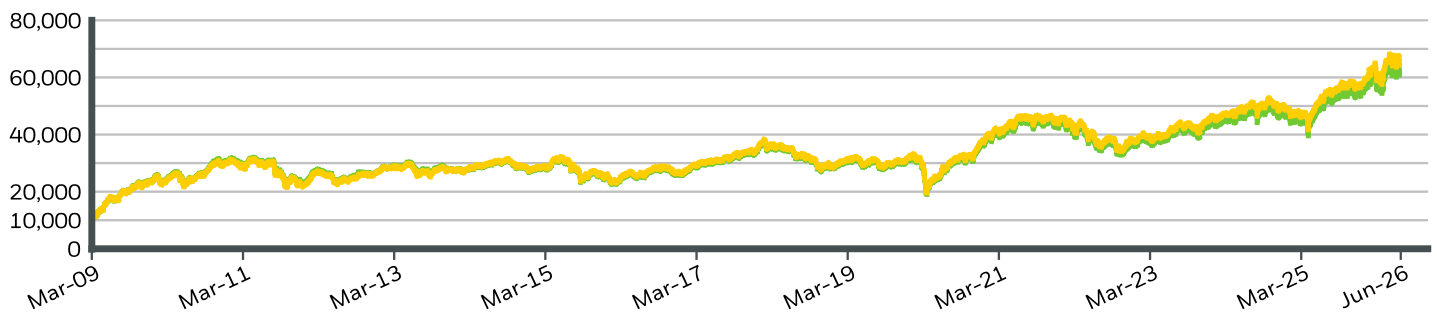

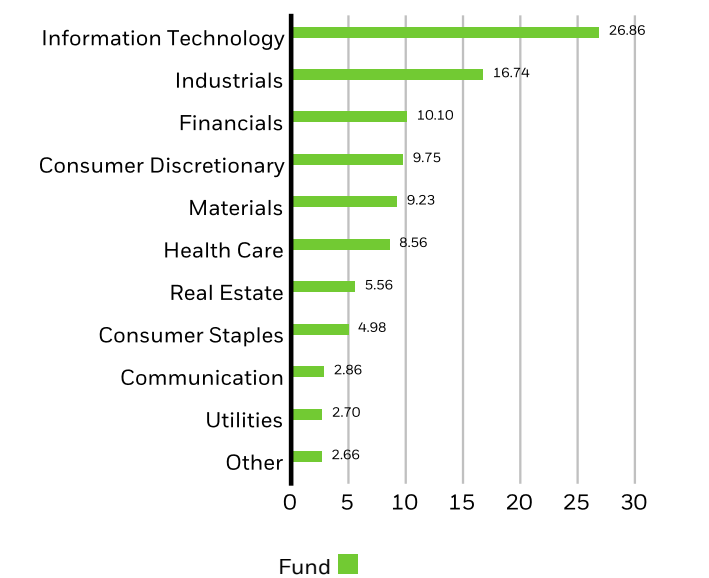

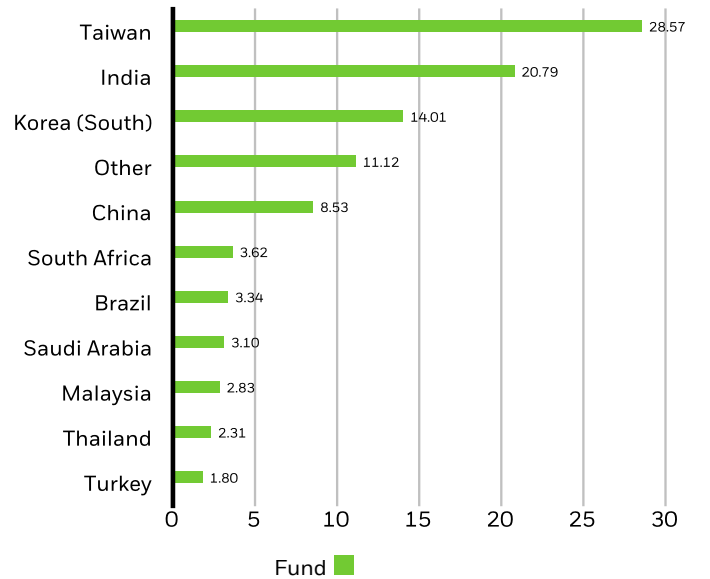
