FUND OVERVIEW

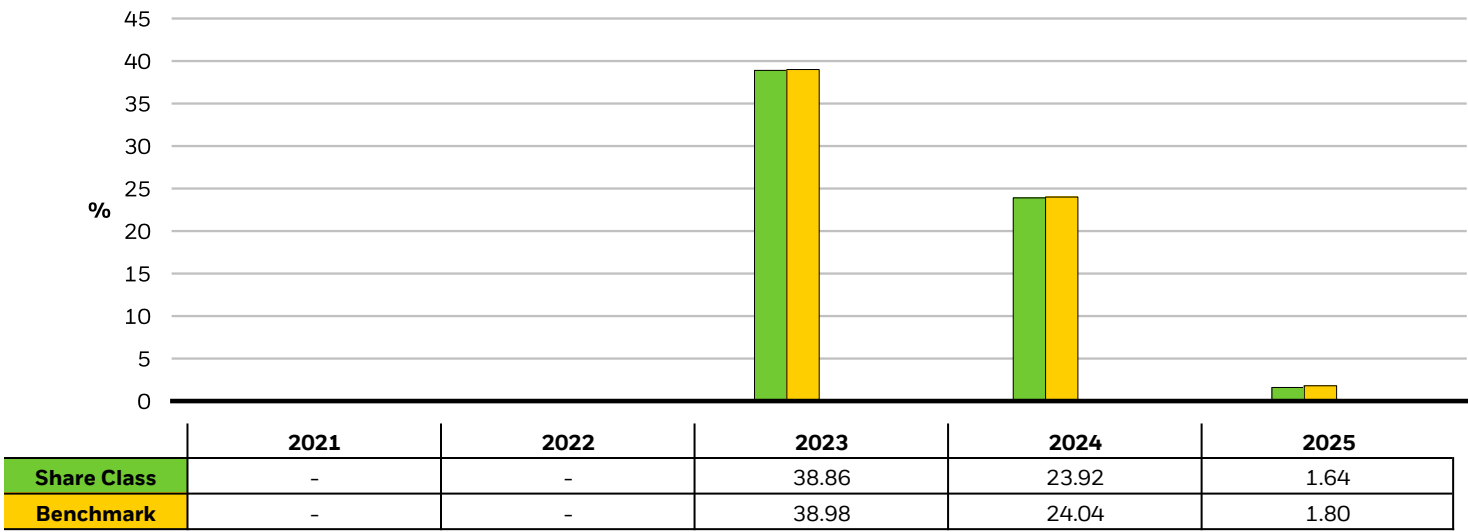

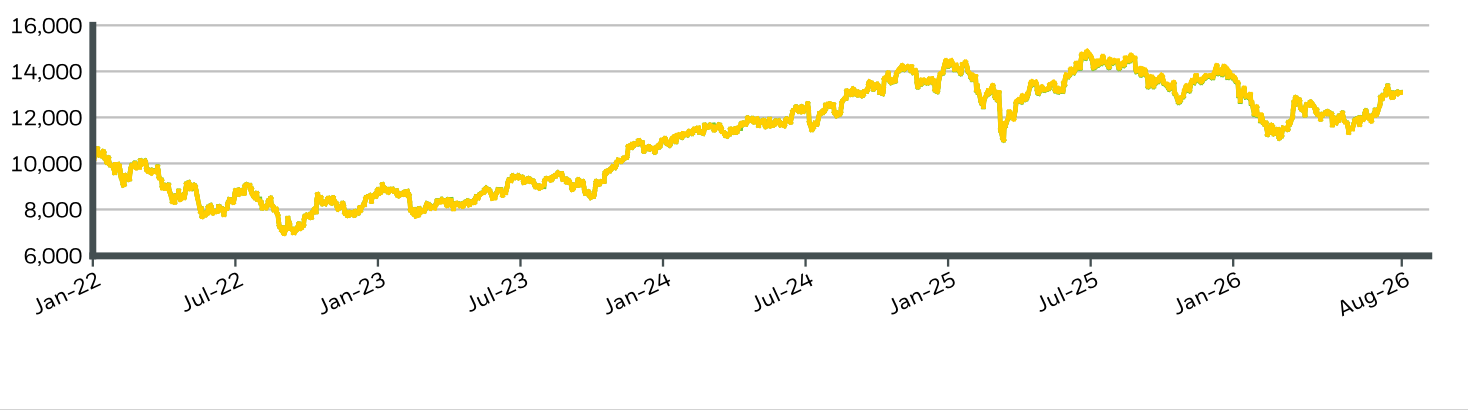

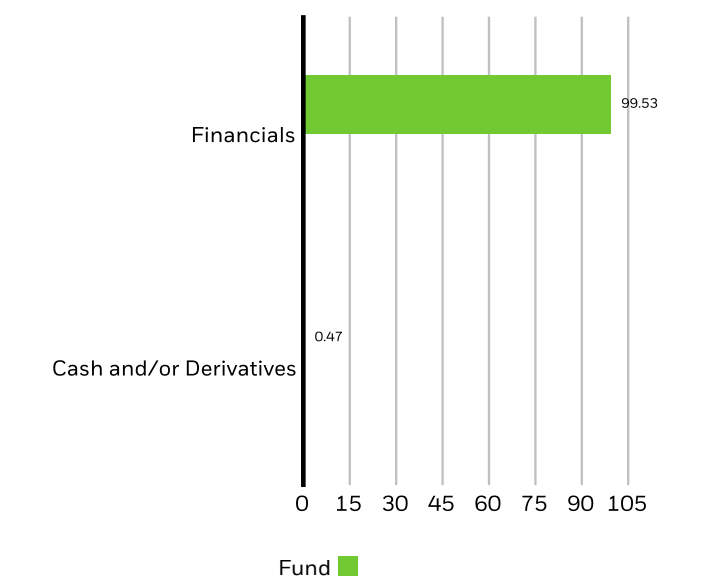

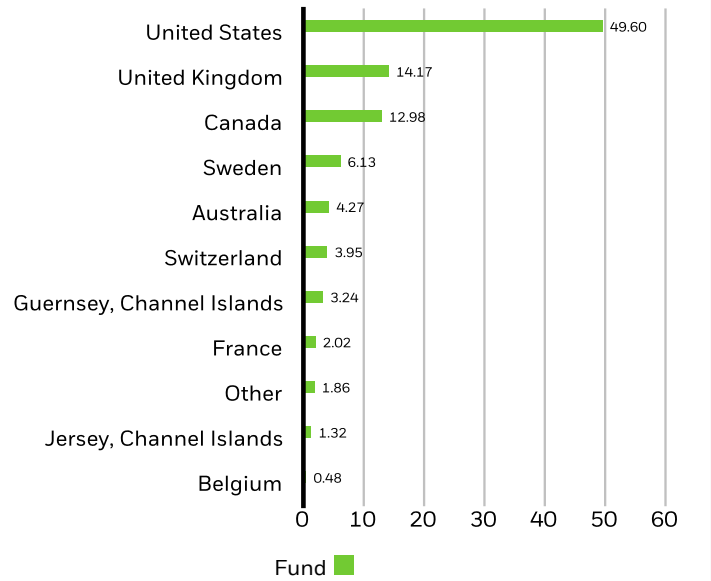
