FUND OVERVIEW

- The Fund aims to provide a return (gross of charges) on your investment (generated through an increase to the value of the assets held by the Fund and/or income received from those assets) by tracking closely the performance of the Bloomberg Global Aggregate Treasuries Index, the Fund's benchmark index.
- The Fund is passively managed and the investment manager has limited discretion to select the Fund's investments and in doing so may take into consideration the benchmark index. The Fund invests in fixed income securities (such as bonds) that make up the benchmark index. The Fund may at times invest indirectly via other fixed income-related investments (i.e. other investments whose value is related to debt giving exposure to such fixed income securities), or in other fixed income securities not in the index.
- The benchmark index tracks the performance of global investment grade treasury bonds from both developed and emerging markets. Qualifying securities must have: (i) an investment grade rating (i.e. meet a specified level of credit worthiness); (ii) a minimum time remaining to final maturity; (i.e. the time until they become due for repayment and (iii) a minimum outstanding amount based on thresholds determined by the index provider.

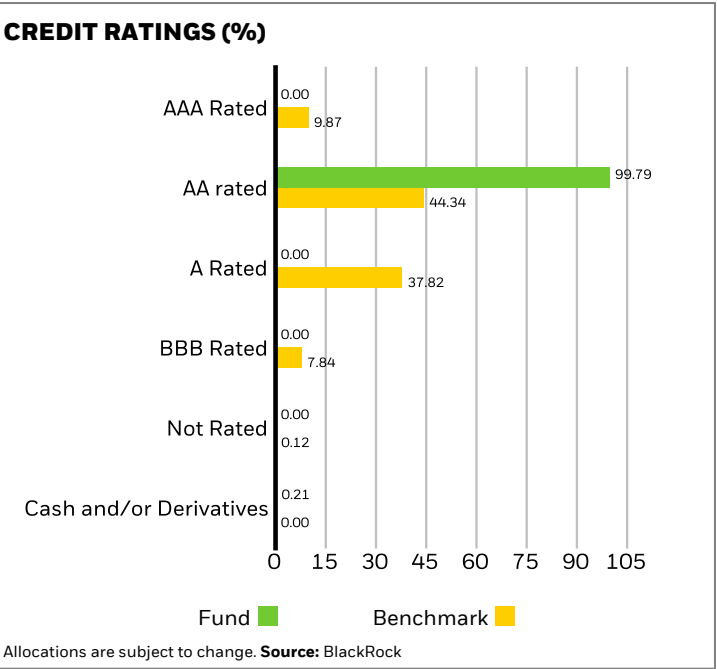
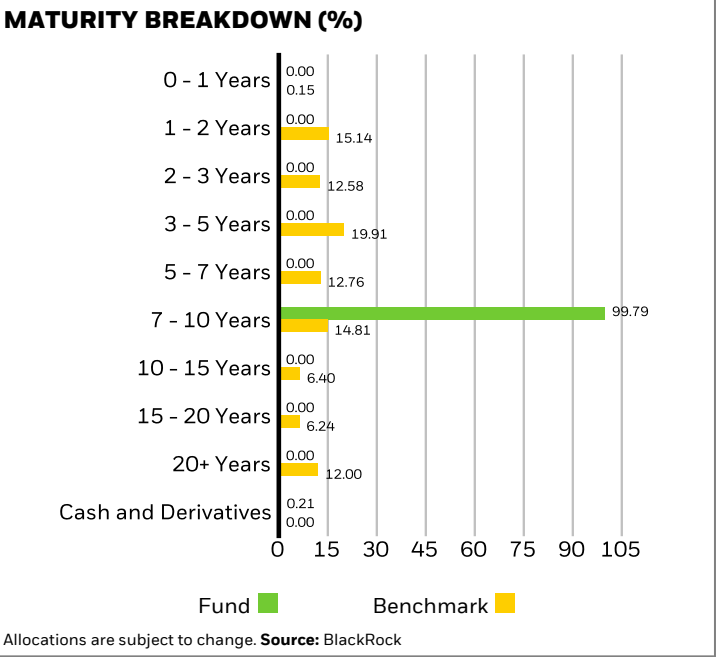
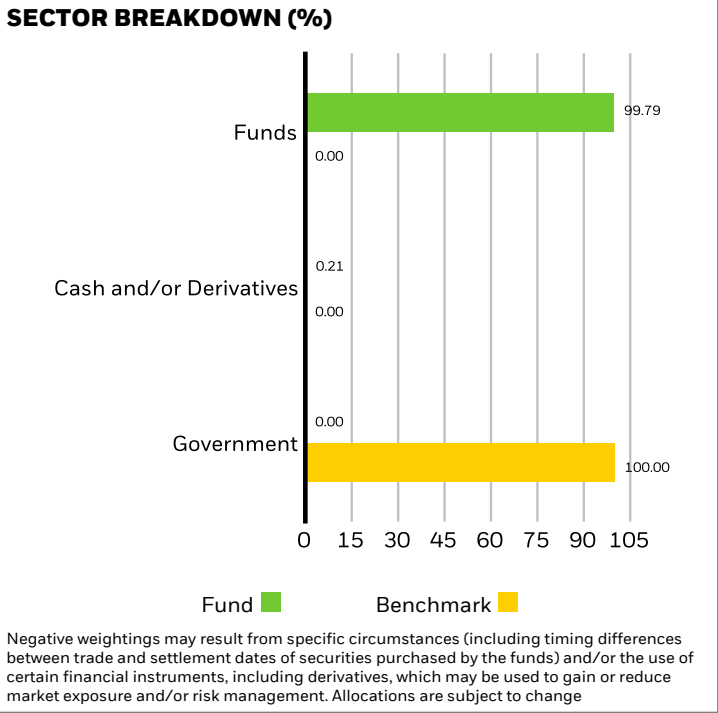

GLOSSARY

Effective Duration: Effective duration is a measure of a fund's interest-rate sensitivity. Put simply, the longer a fund's duration, the more sensitive the fund is to shifts in interest rates. So a fund with a duration of 10 years is twice as volatile as a fund with a five-year duration.

Yield to Maturity: Yield to Maturity (YTM) is the discount rate that equates the present value of bond's cash flows with its market price (including accrued interest). The fund YTM is the weighted average of fund's individual bond holding YTM's based upon Net Asset Value ('NAV'). The measure does not include fees and expenses. For callable bonds, YTM is the Yield-to-Worst.
