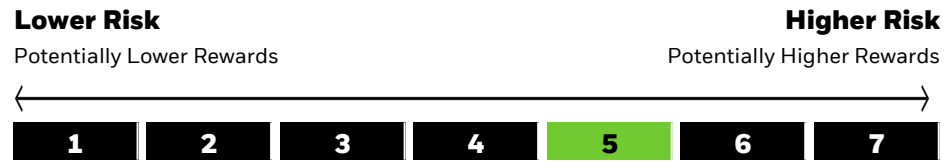
FUND OVERVIEW

The Fund aims to achieve a total return on your investment, through a combination of capital growth and income on the Fund's assets, which reflects the return of the MSCI ACWI Select Telecommunication Services Screened 35/20 Capped Index (the "Index").

Exposure to the GICS telecommunication services industry group which includes companies whose primary business involves the provision of fixed-line, cellular and/or wireless telecommunication services; providers of communications and/or high-density data transmission; producers of interactive gaming products and companies engaging in content and information creation or distribution.

"The Index" (MSCI ACWI Select Telecommunication Services Screened 35/20 Capped Index) excludes companies that are classified as violating the United Nations Global Compact principles and those identified by the index provider as being involved in controversies that have a negative ESG impact on their operations and/or products and services based on an MSCI ESG controversy score.
- 3. Exposure to large and mid capitalisation stocks across developed and emerging market countries.

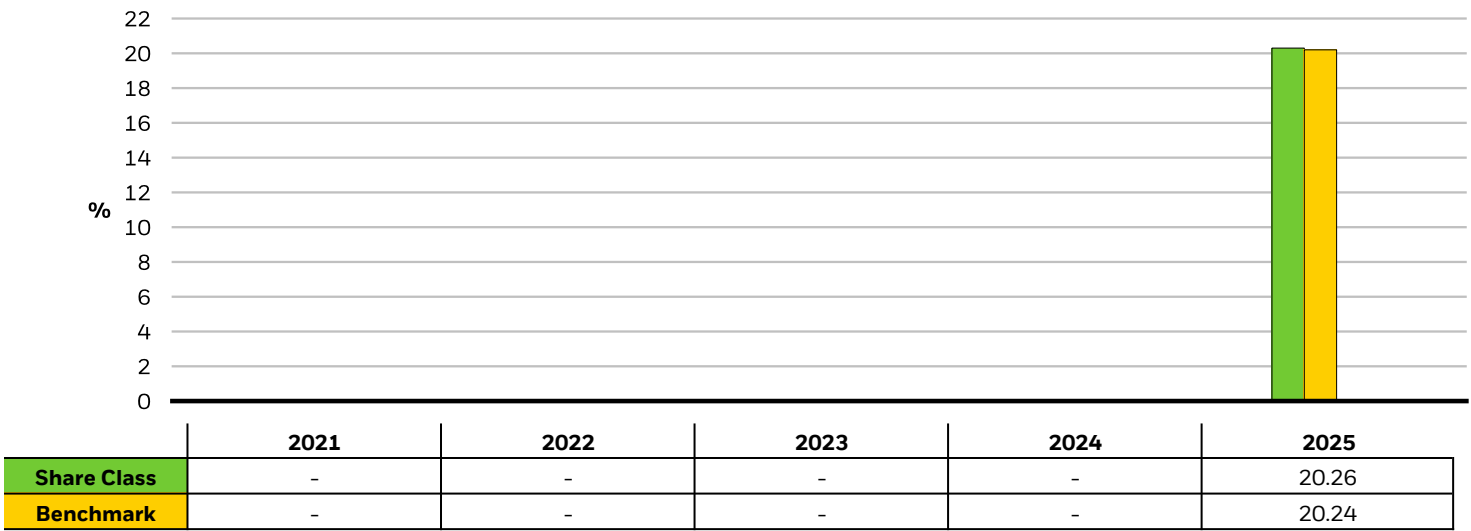

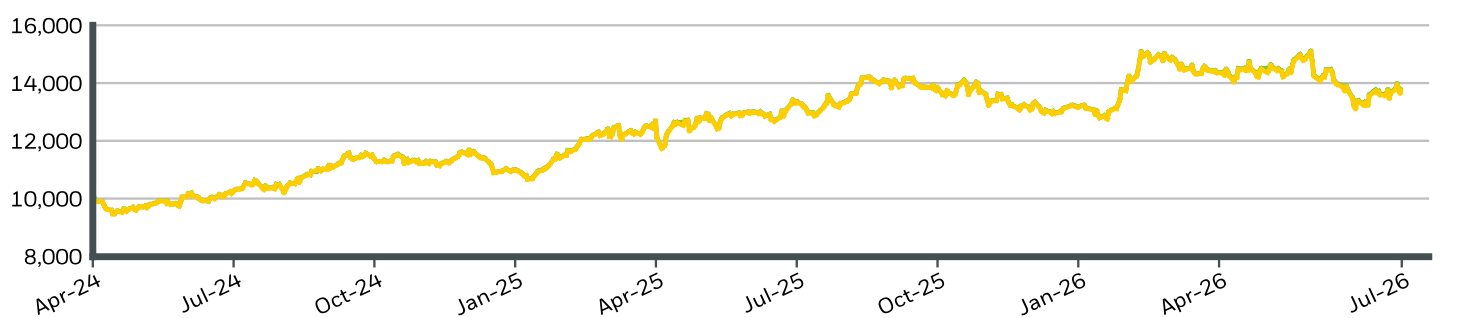

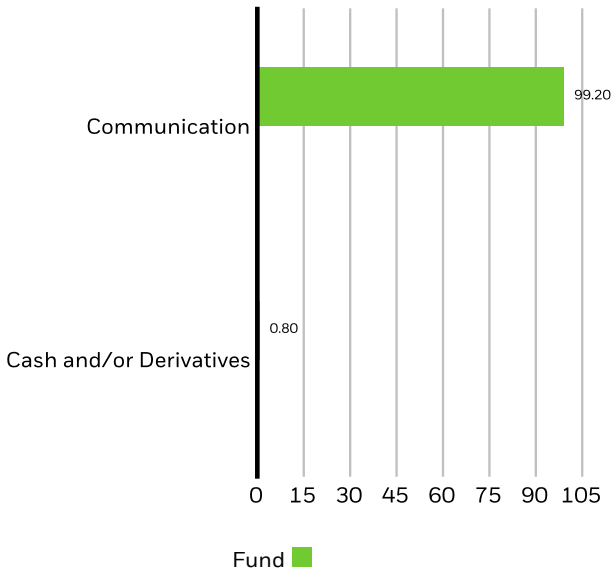

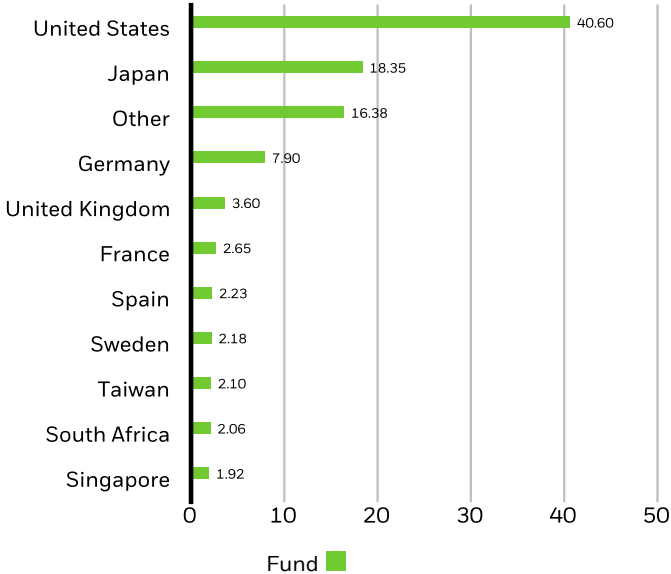
