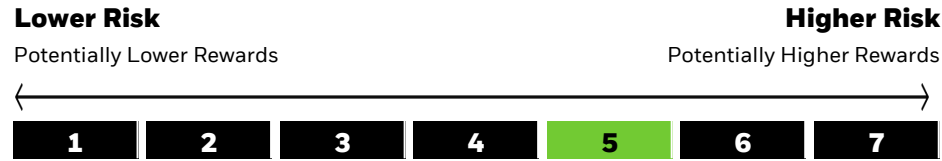

FUND OVERVIEW

The Fund seeks to provide investors with a return, through a combination of capital growth and income, which reflects the return of the MSCI Europe Climate Paris Aligned Benchmark Select Index.

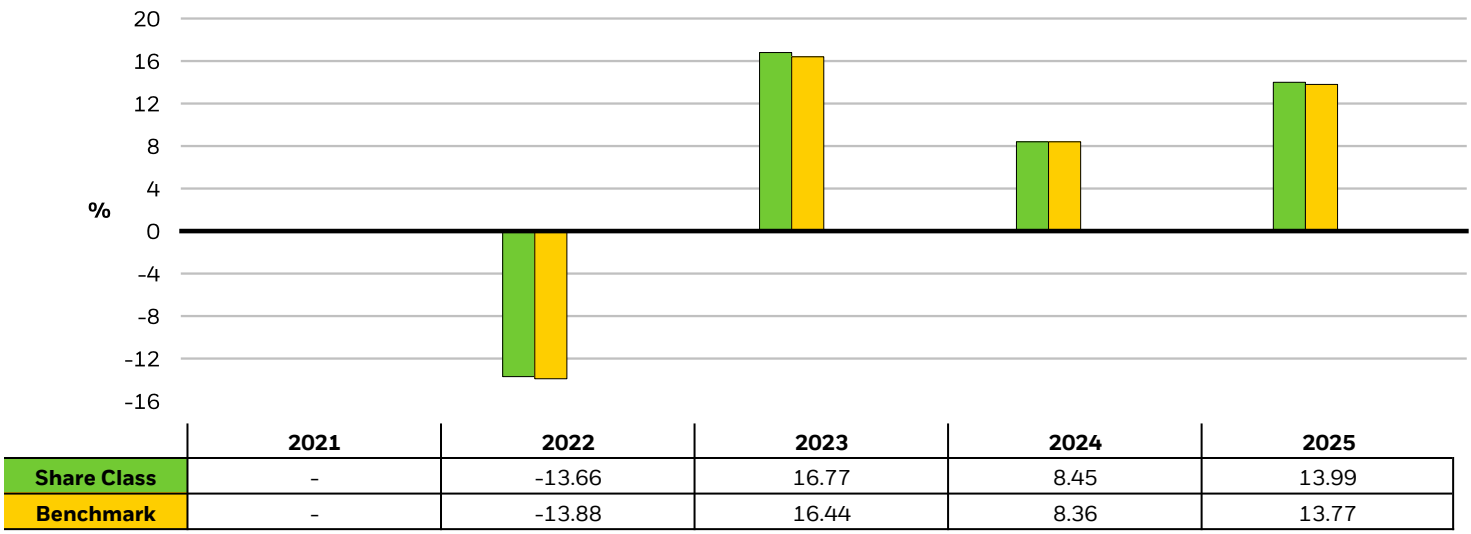

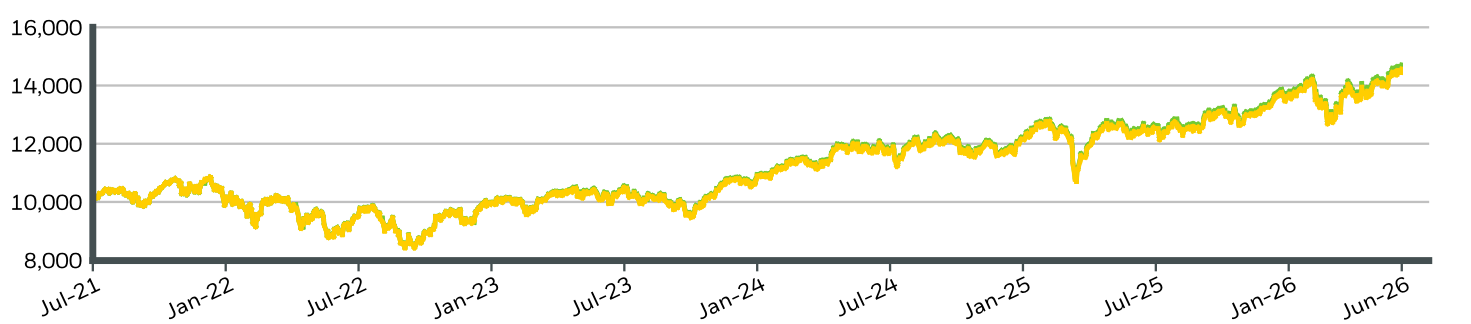

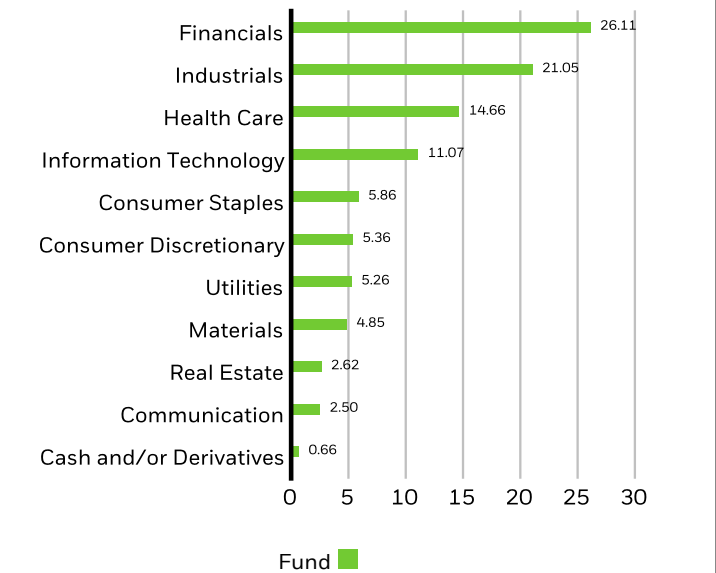

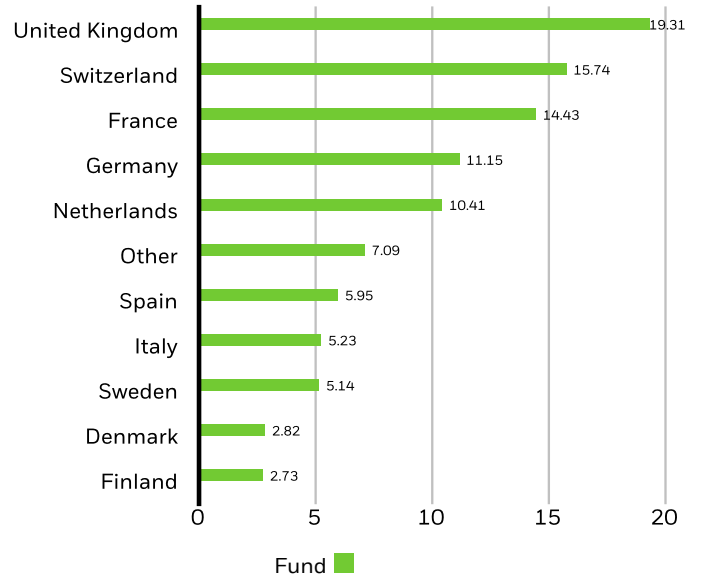
