KEY RISKS:

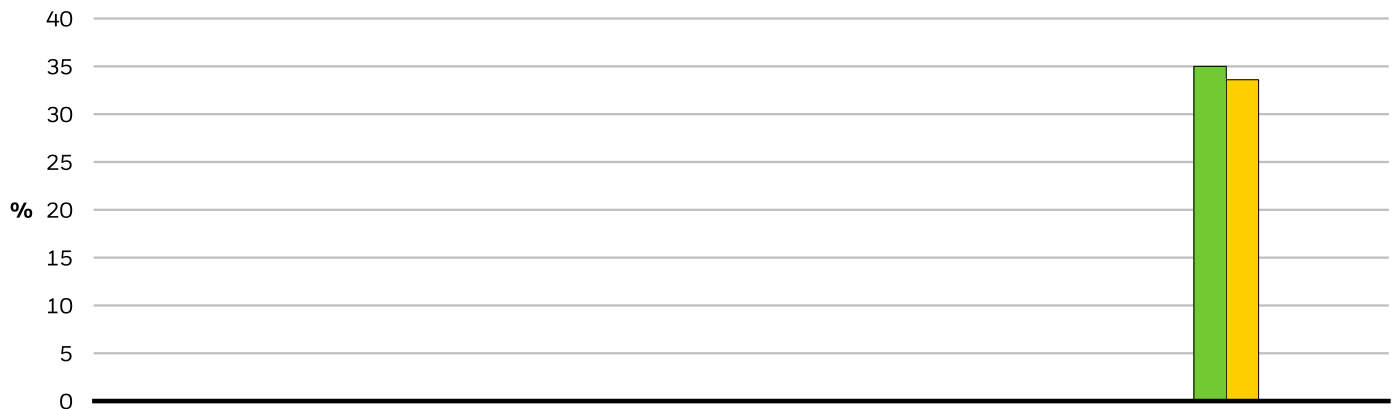

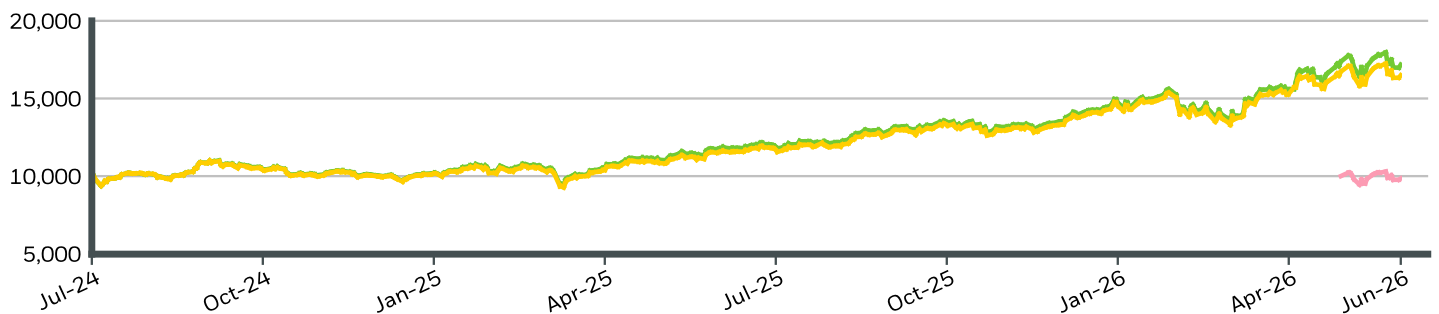

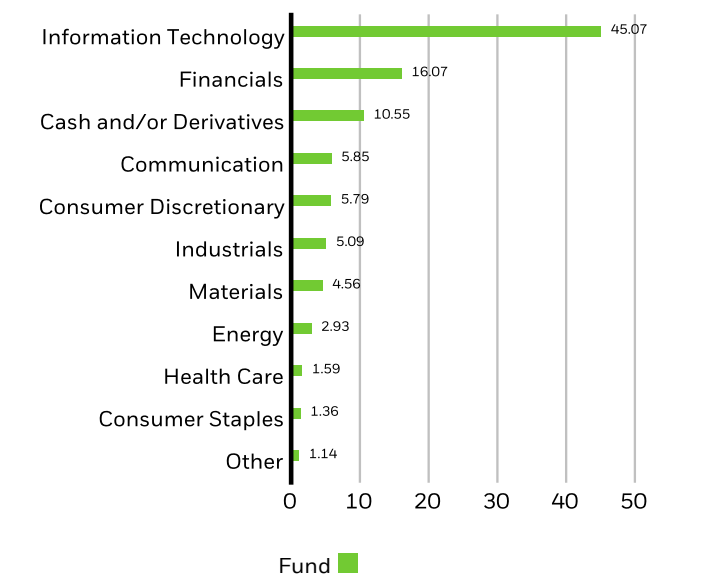

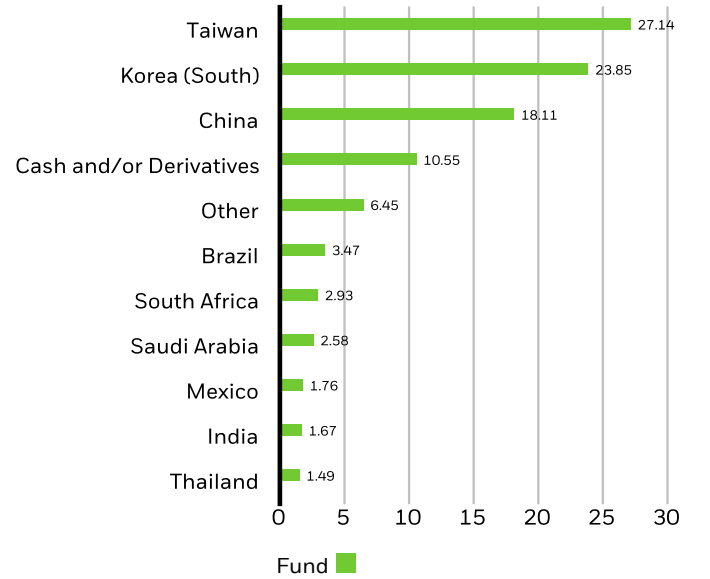
