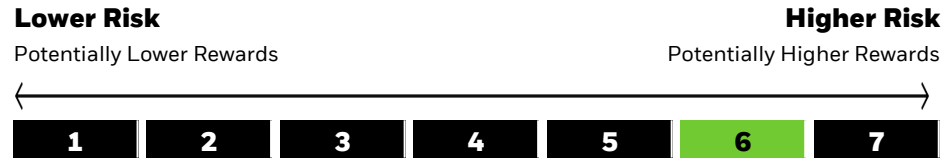
FUND OVERVIEW

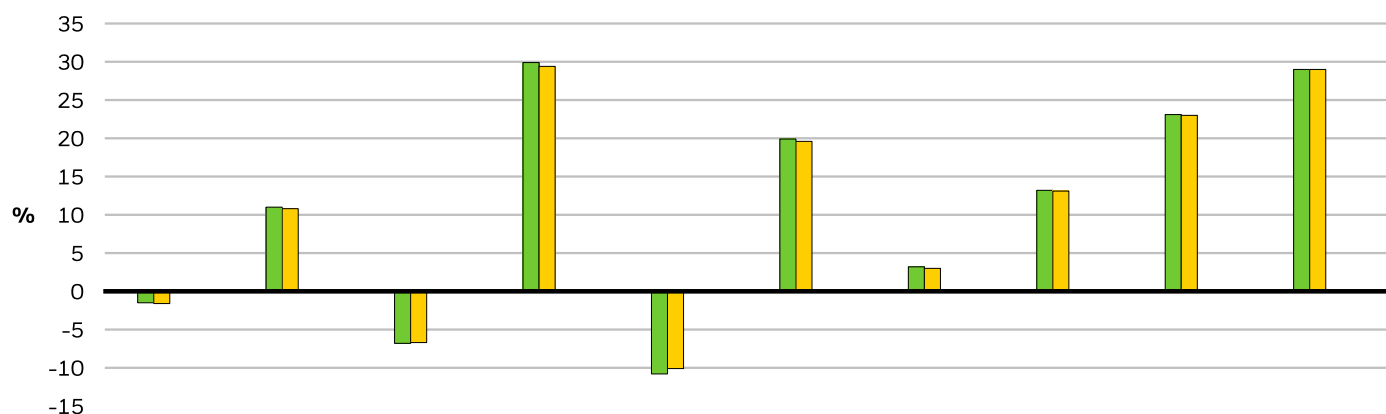

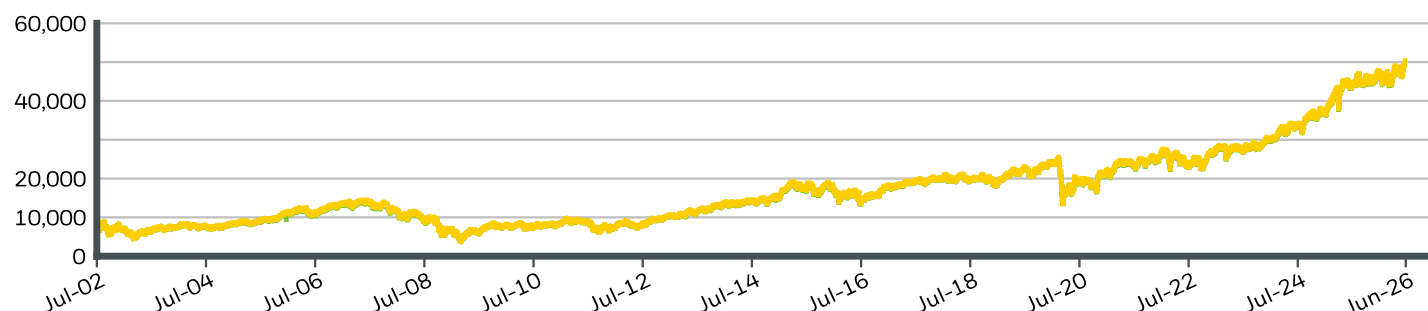

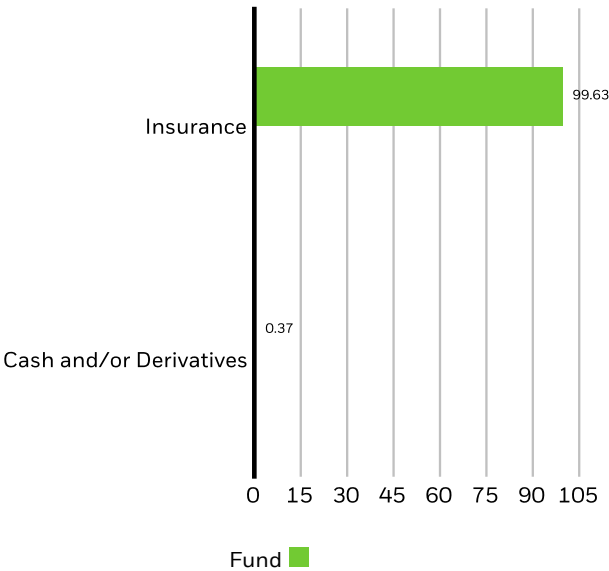

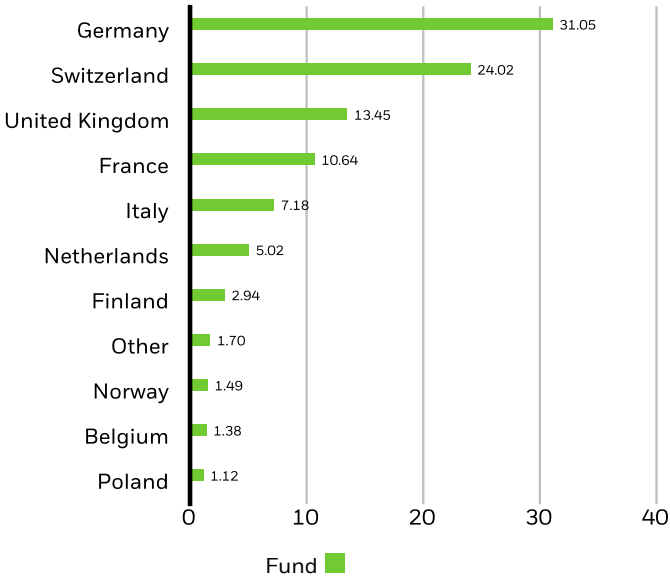
