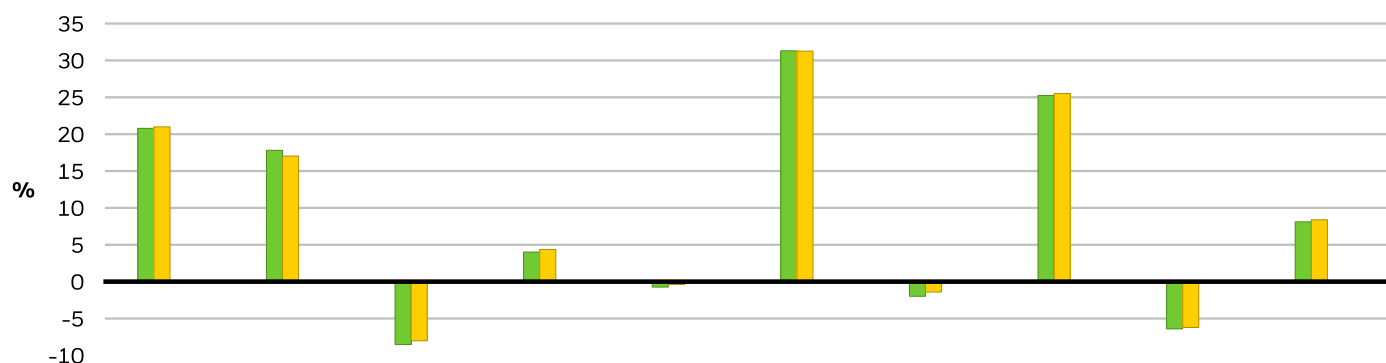

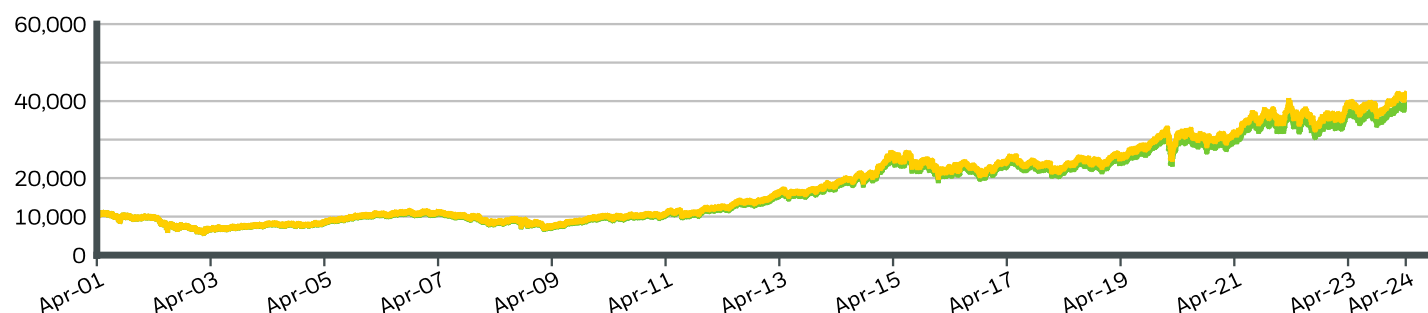

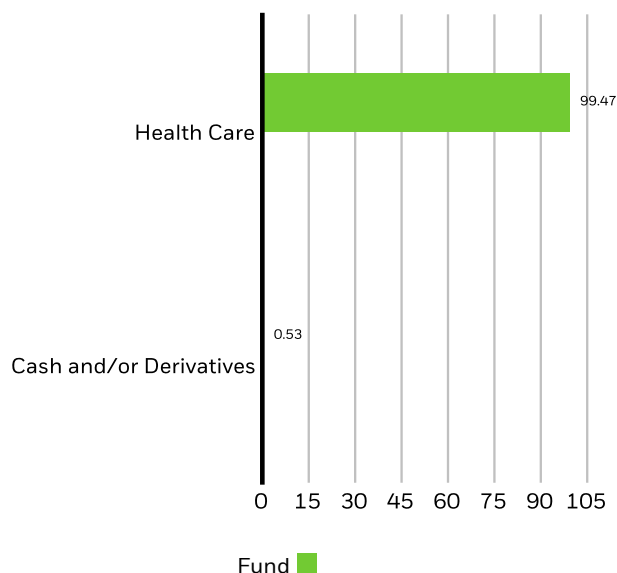

#### SECTOR BREAKDOWN (%)

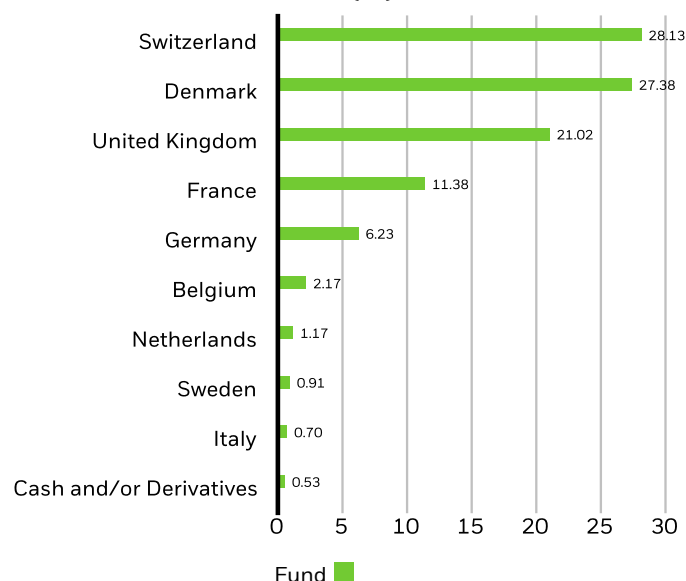

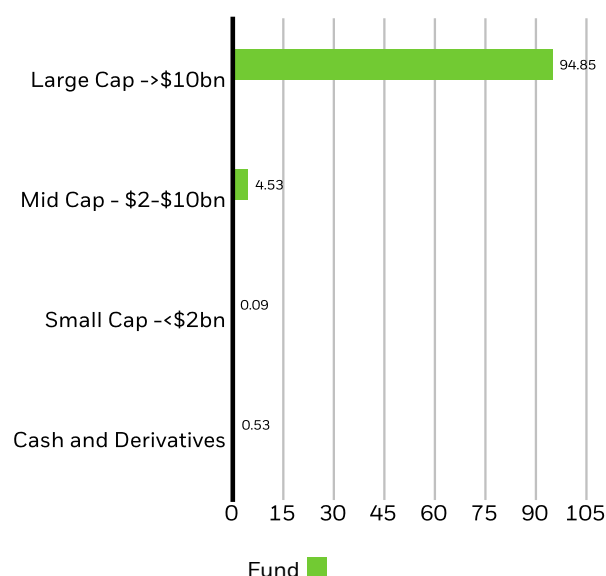

## GLOSSARY
