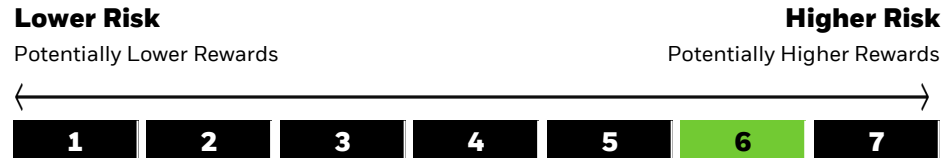

The Fund aims to achieve a return on your investment, through a combination of capital growth and income on the Funds' assets, which reflects the return of the MSCI USA Screened Index, the Fund's benchmark index (Index).

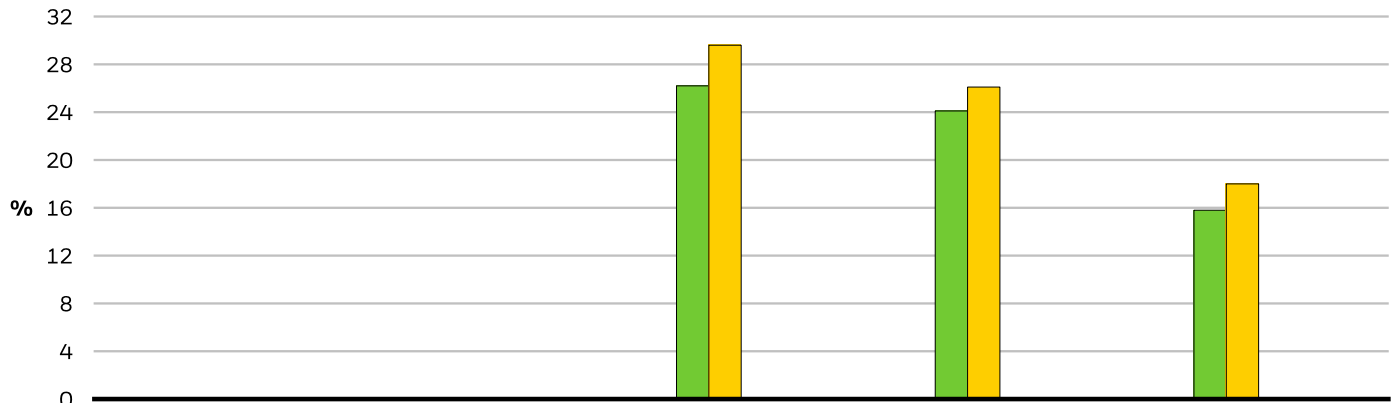

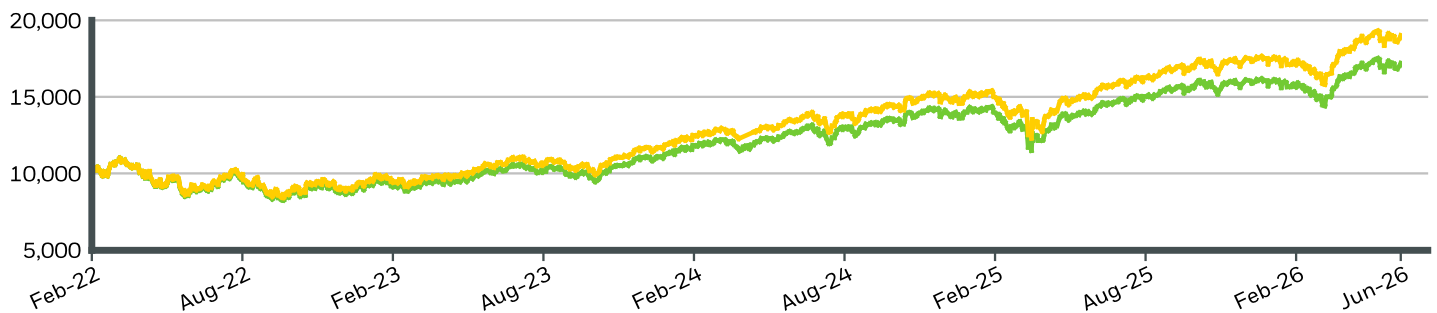

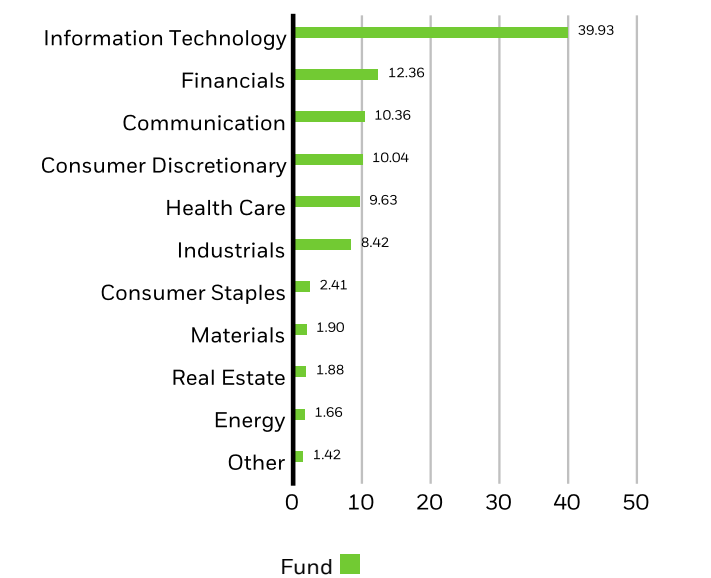
