FUND OVERVIEW

The Fund aims to achieve a total return on your investment, through a combination of capital growth and income on the Fund's assets, which reflects the return of the MSCI USA Transition Aware Select Index, the Fund's benchmark index ("Index").

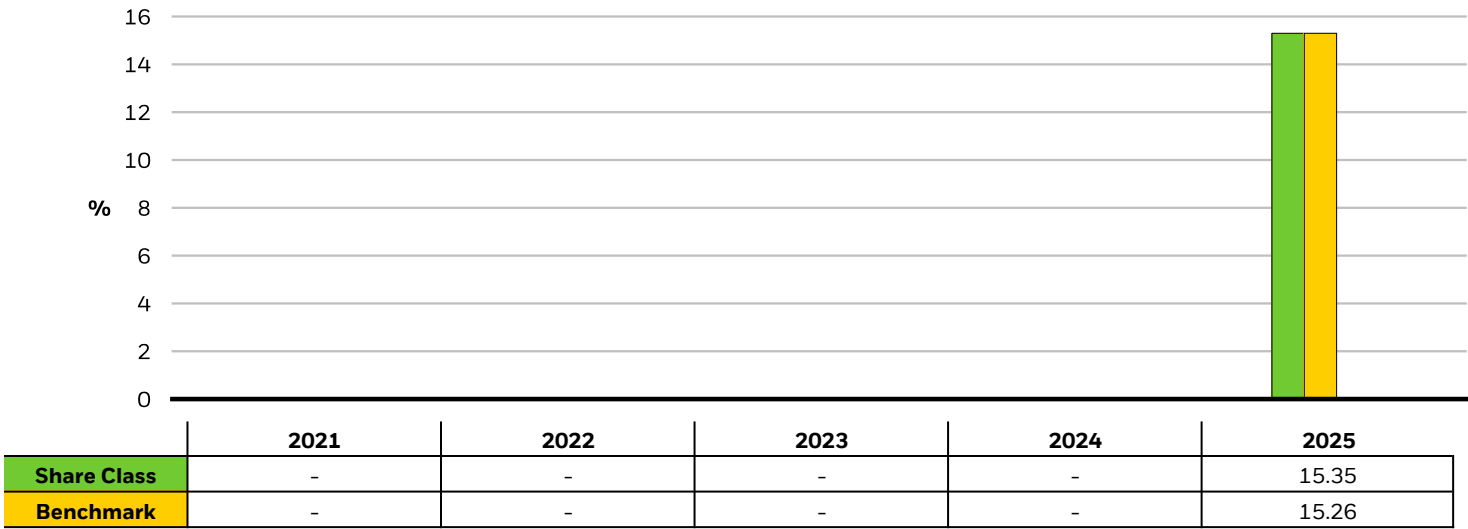

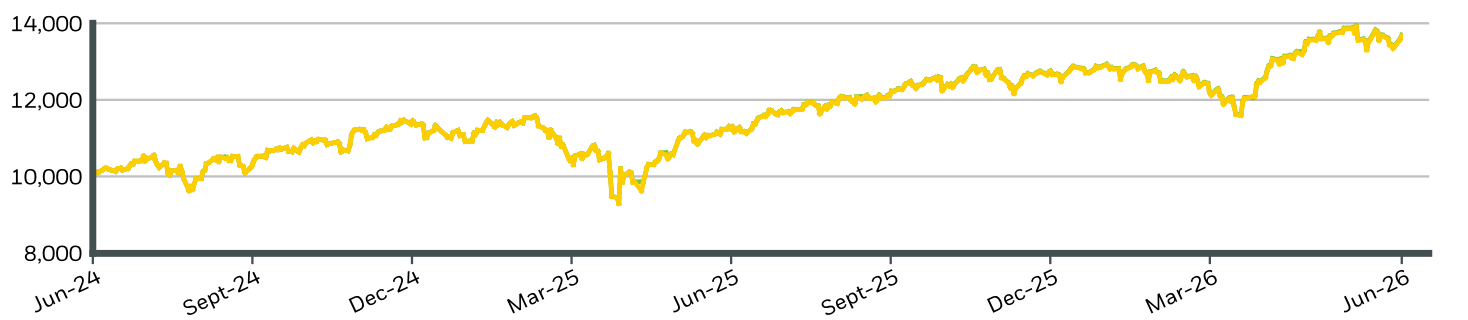

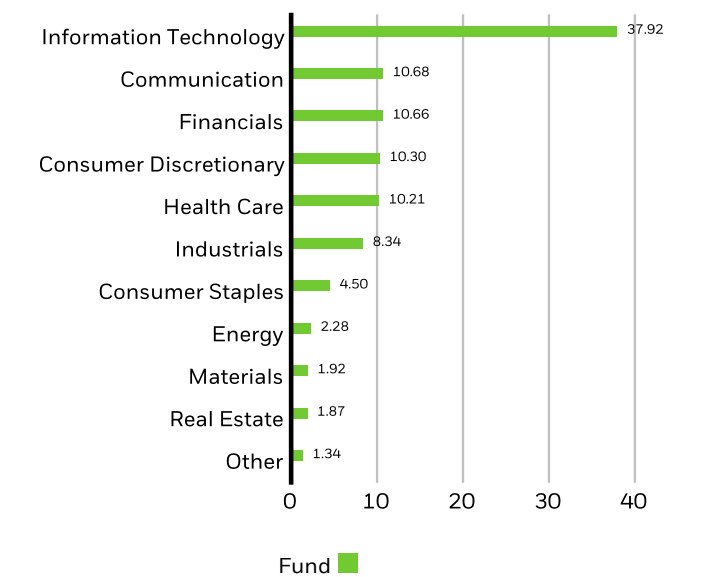
