### Annual Shareholder Report — October 31, 2025

#### What were the Fund costs for the last year? (based on a hypothetical \$10,000 investment)

#### How did the Fund perform last year?

- For the reporting period ended October 31, 2025, the Fund returned 8.83%.
- For the same period, the Bloomberg U.S. Universal Index returned 6.51% and the Bloomberg US High Yield Fallen Angel 3% Capped Index returned 8.80%.

#### What contributed to performance?

By sector, bonds in the communications sector contributed the most to the Fund’s return during the reporting period, supported by wirelines issues. Within the consumer cyclicals sector, issues from retailers also contributed. Within credit quality, the lowest risk rating of high-yield bonds, rated Ba by Moody’s contributed the most to performance, followed by bonds rated B. Fallen angels are high yield bonds that were previously investment grade. Anticipation of rate cuts caused spreads (the difference in the yield between two bonds with similar maturities but different credit qualities) on corporate debt to significantly narrow during the reporting period. Mixed economic signals and ongoing global trade tensions also influenced bond returns, while the late-period U.S. government shutdown added to market volatility. After cutting rates in December of 2024, the Federal Reserve held policy rates steady through the first part of the year, before cutting rates by 25 basis points in both September and October 2025 as evidence of a cooling labor market outweighed persistent, though elevated, inflation concerns.

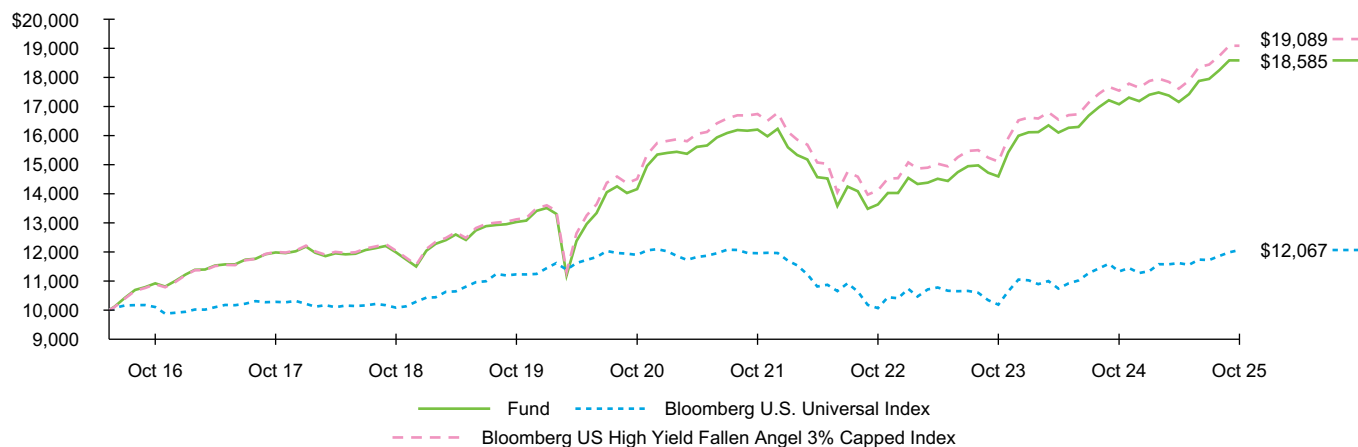
#### What detracted from performance?
