

# iShares iBonds 2031 Term High Yield and Income ETF IBHK | Cboe BZX Exchange Annual Shareholder Report — October 31, 2025

## How did the Fund perform last year?

- For the reporting period ended October 31, 2025, the Fund returned 7.57%.
- For the same period, the Bloomberg U.S. Universal Index returned 6.51% and the Bloomberg 2031 Term High Yield and Income Index returned 7.89%.

## What contributed to performance?

Anticipation of rate cuts caused spreads (the difference in the yield between two bonds with similar maturities but different credit qualities) on high-yield debt to narrow during the reporting period. Mixed economic signals and ongoing global trade tensions also influenced bond returns, while the late-period U.S. government shutdown added to market volatility. After cutting rates in December of 2024, the Federal Reserve held policy rates steady through the first part of the year, before cutting rates by 25 basis points in both September and October 2025 as evidence of a cooling labor market outweighed persistent, though elevated, inflation concerns.

For Term Funds with earlier maturity dates, an allocation to bonds in the consumer cyclicals and communications sectors added to returns. Term Funds with later maturity dates were supported by an allocation to consumer cyclical and industrial sectors. Additionally, Term Funds across maturity dates benefited from bonds on the lower risk spectrum of high yield (those rated Ba and B Moody’s).

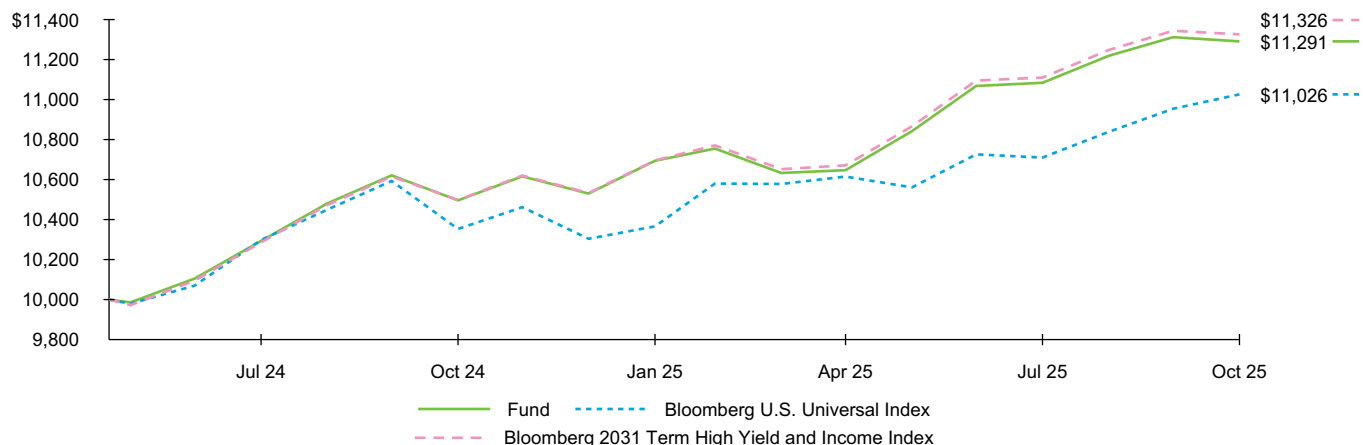
## What detracted from performance?
