### How did the Fund perform last year?

- For the reporting period ended October 31, 2025, the Fund returned 4.85%.
- For the same period, the ICE BofA US Broad Market Index returned 4.42% and the ICE 2035 Maturity US Inflation-Linked Treasury Index returned 4.84%.

### What contributed to performance?

Mixed economic signals, shifting monetary policies, and ongoing global trade tensions influenced Treasury Inflation Protected Securities (“TIPS”) returns during the reporting period, while the late-period U.S. government shutdown added to market volatility. After cutting rates in December of 2024, the Federal Reserve held policy rates steady through the first part of the year, before cutting rates by 25 basis points in both September and October 2025 as evidence of a cooling labor market outweighed persistent, though elevated, inflation concerns.

In this landscape, Term Funds with earlier maturity dates benefited from bonds between five-and-seven years, while bonds between seven-and-ten-years contributed to Term Funds with later maturity dates.

### What detracted from performance?

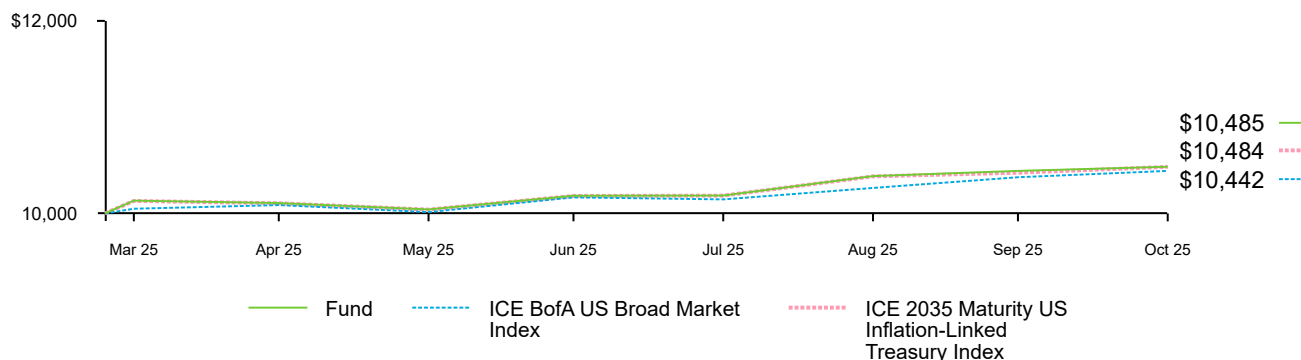
There were no notable detractors from the Fund’s performance during the reporting period.
