### Annual Shareholder Report — February 28, 2026

#### What were the Fund costs for the last year? (based on a hypothetical \$10,000 investment)

#### How did the Fund perform last year?

- For the reporting period ended February 28, 2026, the Fund returned 6.74%.
- For the same period, the Bloomberg U.S. Universal Index returned 6.53% and the Markit iBoxx USD Liquid Investment Grade Index returned 6.82%.

#### What contributed to performance?

U.S. bond markets gained during the reporting period, supported by a resilient domestic economy despite conflicting data. The Federal Reserve (“Fed”) reduced rates by 75 basis points across three 25 basis point rate cuts in late 2025, prompted by a cooling labor market amid elevated inflation. The yield curve (the difference between a shorter-term bond and a longer-term bond, most often gauged by the two-year Treasury note and the 10-year Treasury note) continued to steepen as rate cuts pushed shorter-term yields lower. (Bond yields move inversely to prices.)

Against this backdrop, investment-grade corporate bonds outperformed Treasuries, reflecting solid U.S. economic growth, strong risk appetite, and confidence in corporate earnings. High-yield bonds also posted positive returns, supported by interest rate cuts and stronger investor demand for risk assets.

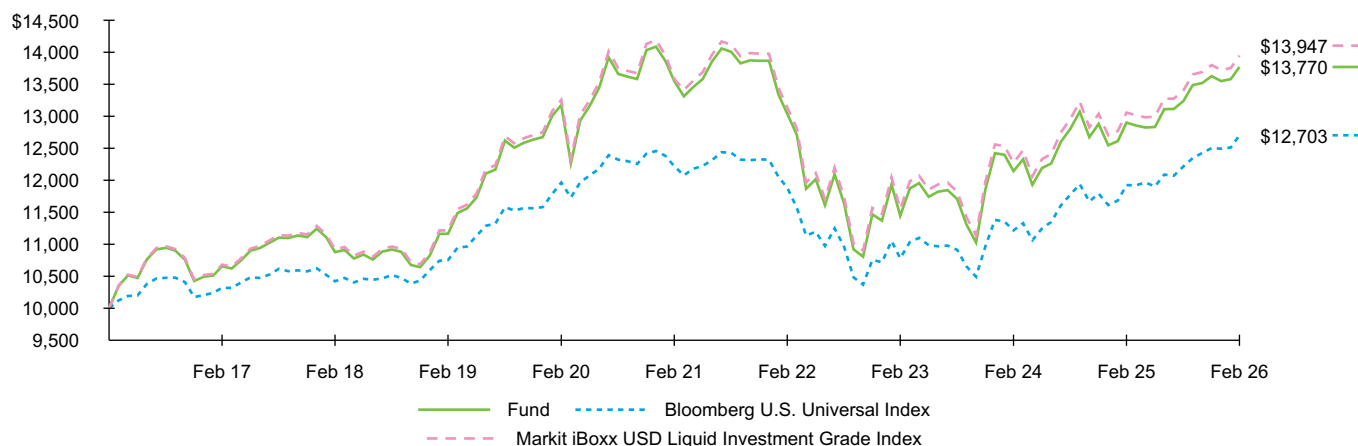
#### What detracted from performance?
