What were the Fund costs for the last year?

How did the Fund perform last year?

- For the reporting period ended October 31, 2025, the Fund returned 6.11%.
- For the same period, the ICE BofA US Broad Market Index returned 6.13% and the ICE U.S. Treasury 0-5 Year Inflation Linked Bond Index (Spliced) returned 6.08%.

What contributed to performance?

Mixed economic signals, shifting monetary policies, and ongoing global trade tensions influenced short-term Treasury Inflation Protected Securities (“TIPS”) returns during the reporting period, while the late-period U.S. government shutdown added to market volatility. After cutting rates in December of 2024, the Federal Reserve held policy rates steady through the first part of the year, before cutting rates by 25 basis points in both September and October 2025 as evidence of a cooling labor market outweighed persistent, though elevated, inflation concerns. This environment led the Fund’s allocation to three- to five-year issues to contribute the most to performance.

What detracted from performance?

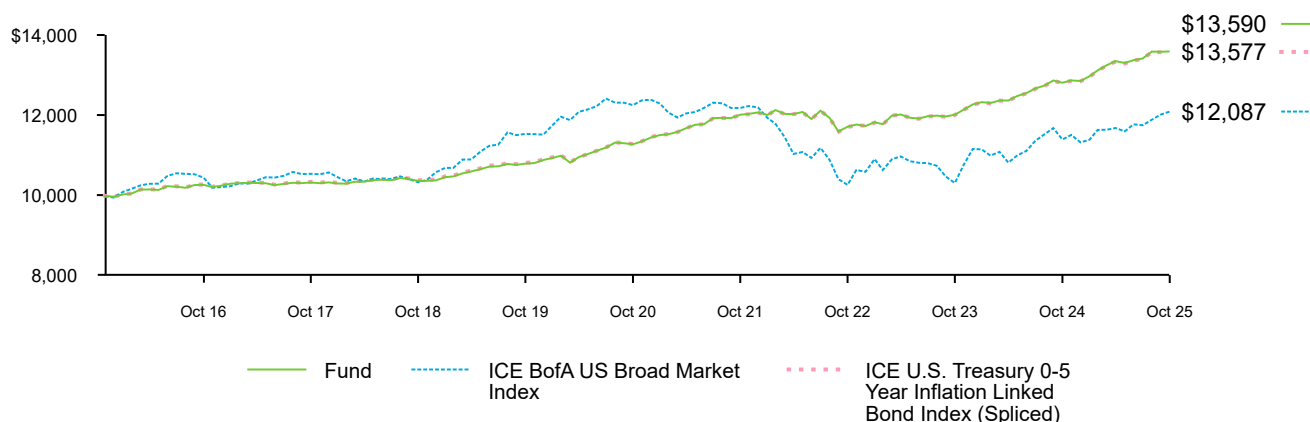
There were no significant detractors from the Fund’s return during the reporting period.
