Options: Many funds have listed options, allowing investors to take multi-directional views.

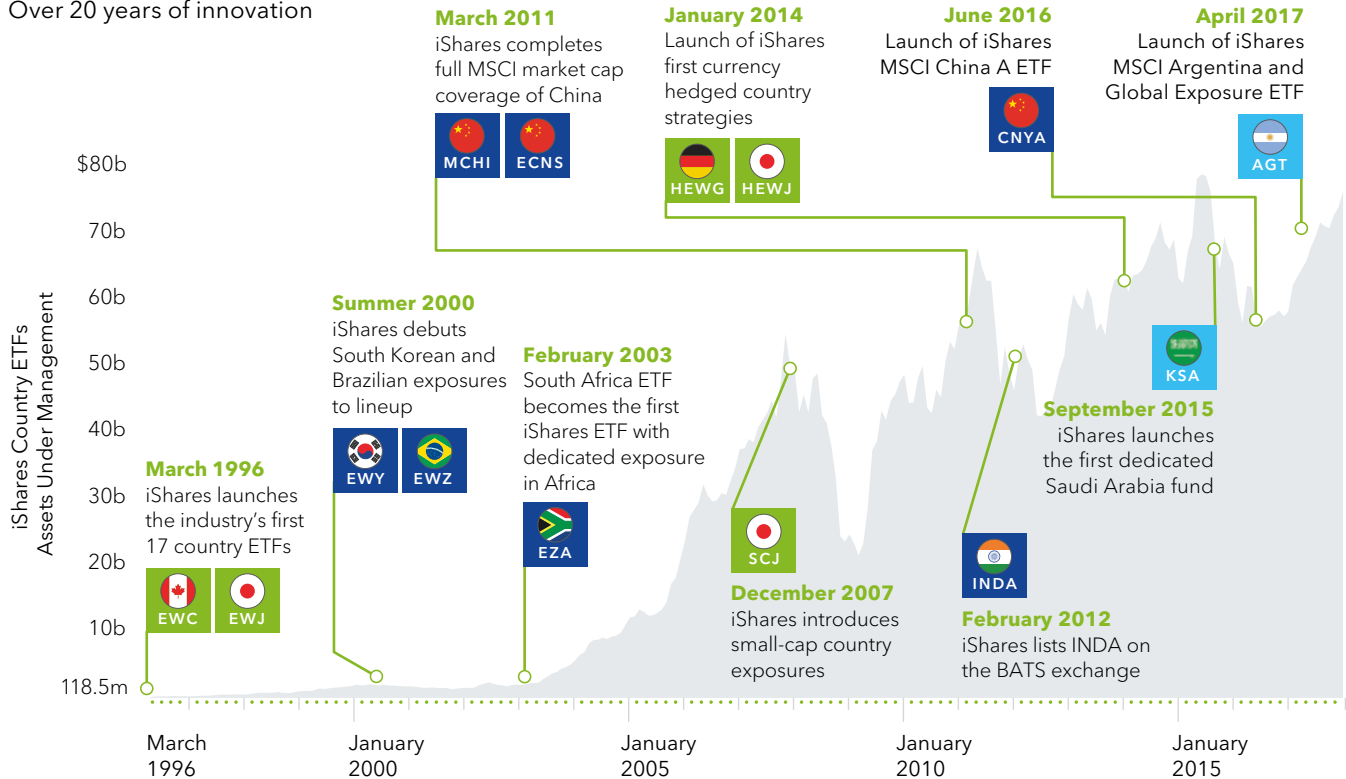
